

BUSINESS IMPACT ESTIMATE

AN ORDINANCE APPROPRIATING \$150,000 FROM A DESIGNATED CONTINGENCY ACCOUNT TO THE SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT TO PROVIDE FUNDING TO NORTHSIDE COMMUNITY INVOLVEMENT, INC. ("NCI") FOR THE COMMUNITIES WITH RESOURCES WORKING TOGETHER FOR THE BETTERMENT OF JACKSONVILLE, FLORIDA PROGRAM (THE "PROGRAM") DESCRIBED HEREIN; INVOKING THE EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH NCI; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH NCI; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND NORTHSIDE COMMUNITY INVOLVEMENT, INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACTS COMPLIANCE DIVISION OF THE FINANCE AND ADMINISTRATION DEPARTMENT; PROVIDING AN EFFECTIVE DATE.
