5 A RESOLUTION AUTHORIZING THE GRANTING OF A NON-  
6 RESIDENTIAL SOLID WASTE COLLECTION AND  
7 TRANSPORTATION FRANCHISE TO FIVE TALENT  
8 SERVICES, LLC D/B/A MOBILEDUMPS OF JACKSONVILLE  
9 PURSUANT TO CHAPTER 380 (SOLID WASTE  
10 MANAGEMENT), PART 6 (NONRESIDENTIAL SOLID WASTE  
11 COLLECTION AND TRANSPORTATION FRANCHISES),  
12 *ORDINANCE CODE*; PROVIDING FOR OVERSIGHT BY THE  
13 DEPARTMENT OF PUBLIC WORKS, SOLID WASTE  
14 DIVISION; PROVIDING AN EFFECTIVE DATE.

16 **WHEREAS**, Five Talent Services, LLC d/b/a Mobiledumps of  
17 Jacksonville ("Five Talent") has submitted an application for a non-  
18 residential solid waste collection and transportation franchise  
19 pursuant to the provisions of Chapter 380, Part 6, *Ordinance Code*;  
20 and

21 **WHEREAS**, the application was reviewed by the Solid Waste  
22 Division of the Department of Public Works; and

23 **WHEREAS**, the Department of Public Works recommends granting a  
24 franchise for non-residential solid waste collection and  
25 transportation to Five Talent; and

26 **WHEREAS**, granting a non-residential solid waste collection and  
27 transportation franchise to Five Talent be in the best interest of  
28 the City and will further the purpose for which the franchise program  
29 was adopted, including, but not limited to, safeguarding public  
30 health, safety and welfare in the collection and transportation of  
31 solid waste through Jacksonville; now therefore

1 **BE IT RESOLVED** by the Council of the City of Jacksonville:

2 **Section 1. Franchise Agreement Authorized.** In accordance  
3 with the provisions of Chapter 380 (Solid Waste Management), Part 6  
4 (Nonresidential Solid Waste Collection and Transportation  
5 Franchises), *Ordinance Code*, the Director of the Public Works  
6 Department is hereby authorized to issue a franchise agreement to  
7 Five Talent Services, LLC d/b/a MobileDumps of Jacksonville for  
8 collection and transportation of non-residential solid waste in the  
9 City of Jacksonville. Five Talent has paid the application fee of  
10 \$1,500.00. A copy of the Non-Residential Solid Waste Collection and  
11 Transportation Franchise Agreement is attached hereto as **Exhibit 1**  
12 and incorporated herein by this reference. A copy of the letter from  
13 the Department of Public Works forwarding Five Talent's application  
14 to the Council for action is attached hereto as **Exhibit 2** and  
15 incorporated herein by this reference.

16 **Section 2. Oversight.** The Solid Waste Division of the  
17 Department of Public Works shall oversee the franchise described  
18 herein.

19 **Section 3. Effective Date.** This Resolution shall become  
20 effective upon signature by the Mayor or upon becoming effective  
21 without the Mayor's signature.
