ORDINANCE 2023-709-E

AN ORDINANCE ADOPTING A SMALL-SCALE AMENDMENT TO THE FUTURE LAND USE MAP SERIES OF THE 2045 COMPREHENSIVE PLAN BY CHANGING THE FUTURE LAND USE DESIGNATION FROM BUSINESS PARK (BP) TO RURAL RESIDENTIAL (RR) ON APPROXIMATELY 1.00± ACRES LOCATED IN COUNCIL DISTRICT 12 AT 0 HALSEMA ROAD SOUTH, BETWEEN CECIL COMMERCE CENTER PARKWAY AND ROAD (R.E. NO. 001932-0010 CHAFFEE SOUTH (PORTION)), OWNED ΒY CTB3, LLC, AS MORE PARTICULARLY DESCRIBED HEREIN, PURSUANT ТО APPLICATION NUMBER L-5852-23C; PROVIDING Α DISCLAIMER THAT THE AMENDMENT GRANTED HEREIN SHALL NOT BE CONSTRUED AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to the provisions of Section 650.402(b), 21 22 Ordinance Code, and Section 163.3187(1), Florida Statutes, an 23 application for a proposed Small-Scale Amendment to the Future Land 24 Use Map series (FLUMs) of the 2045 Comprehensive Plan to change the Future Land Use designation from Business Park (BP) to Rural 25 26 Residential (RR) on 1.00± acres of certain real property in Council 27 District 12 was filed by Carter Keen on behalf of the owner, CTB2, 28 LLC; and

WHEREAS, the Planning and Development Department reviewed the proposed revision and application and has prepared a written report and rendered an advisory recommendation to the City Council with respect to the proposed amendment; and

2 WHEREAS, the Planning Commission, acting as the Local Planning 3 Agency (LPA), held a public hearing on this proposed amendment, with 4 due public notice having been provided, reviewed and considered 5 comments received during the public hearing and made its 6 recommendation to the City Council; and

7 WHEREAS, the Land Use and Zoning (LUZ) Committee of the City 8 Council held a public hearing on this proposed amendment to the 2045 9 Comprehensive Plan, pursuant to Chapter 650, Part 4, Ordinance Code, 10 considered all written and oral comments received during the public 11 hearing, and has made its recommendation to the City Council; and

12 WHEREAS, the City Council held a public hearing on this proposed amendment, with public notice having been provided, pursuant to 13 14 Section 163.3187, Florida Statutes, and Chapter 650, Part 4, Ordinance 15 Code, and considered all oral and written comments received during public hearings, including the data and analysis portions of this 16 proposed amendment 17 to the 2045 Comprehensive Plan and the recommendations of the Planning and Development Department, the 18 19 Planning Commission and the LUZ Committee; and

20 WHEREAS, in the exercise of its authority, the City Council has 21 determined it necessary and desirable to adopt this proposed amendment 22 to the 2045 Comprehensive Plan to preserve and enhance present 23 advantages, encourage the most appropriate use of land, water, and 24 resources consistent with the public interest, overcome present 25 deficiencies, and deal effectively with future problems which may 26 result from the use and development of land within the City of 27 Jacksonville; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:
Section 1. Purpose and Intent. This Ordinance is adopted
to carry out the purpose and intent of, and exercise the authority
set out in, the Community Planning Act, Sections 163.3161 through

163.3248, Florida Statutes, and Chapter 166, Florida Statutes, as
 amended.

3 Section 2. Subject Property Location and Description. The approximately 1.00± acres are located in Council District 12 at 0 4 5 Halsema Road South, between Cecil Commerce Center Parkway and Chaffee Road South (R.E. No. 001932-0010 (portion)), as more particularly 6 7 described in Exhibit 1, dated April 24, 2023, and graphically depicted 8 in Exhibit 2, both attached hereto and incorporated herein by this 9 reference (the "Subject Property").

Section 3. Owner and Applicant Description. The Subject
Property is owned by CTB2, LLC. The applicant is Carter Keen, 710
Halsema Road South, Jacksonville, Florida 32221; (904) 400-0574.

Section 4. Adoption of Small-Scale Land Use Amendment. The City Council hereby adopts a proposed Small-Scale revision to the Future Land Use Map series of the 2045 Comprehensive Plan by changing the Future Land Use Map designation of the Subject Property from Business Park (BP) to Rural Residential (RR), pursuant to Application Number L-5852-23C.

19 Applicability, Effect and Legal Status. Section 5. The applicability and effect of the 2045 Comprehensive Plan, as herein 20 21 amended, shall be as provided in the Community Planning Act, Sections 22 163.3161 through 163.3248, Florida Statutes, and this Ordinance. All 23 development undertaken by, and all actions taken in regard to 24 development orders by governmental agencies in regard to land which 25 is subject to the 2045 Comprehensive Plan, as herein amended, shall 26 be consistent therewith as of the effective date of this amendment 27 to the plan.

Section 6. Effective Date of this Plan Amendment.

(a) If the amendment meets the criteria of Section 163.3187, *Florida Statutes*, as amended, and is not challenged, the effective
date of this plan amendment shall be thirty-one (31) days after

2 (b) If challenged within thirty (30) days after adoption, the 3 plan amendment shall not become effective until the state land 4 planning agency or the Administration Commission, respectively, issue 5 a final order determining the adopted Small-Scale Amendment to be in 6 compliance.

7 Section 7. Disclaimer. The amendment granted herein shall 8 not be construed as an exemption from any other applicable local, state, or federal laws, regulations, requirements, permits or 9 approvals. All other applicable local, state or federal permits or 10 11 approvals shall be obtained before commencement of the development 12 or use, and issuance of this amendment is based upon acknowledgement, representation and confirmation made by the applicant(s), owner(s), 13 14 developer(s) and/or any authorized agent(s) or designee(s) that the 15 subject business, development and/or use will be operated in strict compliance with all laws. Issuance of this amendment does not 16 approve, promote or condone any practice or act that is prohibited 17 or restricted by any federal, state or local laws. 18

19 Section 8. Effective Date. This Ordinance shall become 20 effective upon signature by the Mayor or upon becoming effective 21 without the Mayor's signature.
