## ORDINANCE 2023-868

APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY OF JACKSONVILLE ("CITY"), THAT CERTAIN REVOCABLE PERMIT AND HOLD HARMLESS AGREEMENT ("AGREEMENT") BETWEEN THE CITY, JACKSONVILLE UNIVERSITY, AND OCEARCH FOR THE USE OF A CITY OWNED DOCK FACILITY IN THE MAYPORT COMMUNITY ON SUBMERGED LANDS LEASED PURSUANT TO  $_{
m THE}$ SOVEREIGNTY SUBMERGED LANDS LEASE (BOT FILE #160359172) AUTHORIZED BY ORDINANCE 2022-0215-E, FOR THE DOCKING OF VESSELS USED FOR RESEARCH AND EDUCATIONAL PURPOSES, WITH AN INITIAL TERM OF THIRTY YEARS, WITH FOUR FIVE-YEAR RENEWAL OPTIONS, WITH NO USAGE FEE; PROVIDING FURTHER AUTHORIZATIONS; PROVIDING FOR OVERSIGHT BY THE PARKS, RECREATION AND COMMUNITY SERVICES DEPARTMENT; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Approved and Execution Authorized. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City of Jacksonville ("City"), that certain Revocable Permit and Hold Harmless Agreement between the City, Jacksonville University ("JU") and OCEARCH in substantially the form placed On File with the

Legislative Services Division (the "Agreement"). Said Agreement authorizes JU and OCEARCH, a global non-profit organization conducting shark research, to use and access a City owned dock facility ("Mayport Dock") in the Mayport community located on submerged lands leased pursuant to the Sovereignty Submerged Lands Lease (BOT File #160359172) ("Submerged Land Lease") authorized by Ordinance 2022-0215-E for an initial term of thirty years, with four five-year renewal options, with no usage fee, for the docking of vessels used for research and educational purposes. JU currently leases from the City waterfront property adjacent to the Mayport Dock and located at 4610 Ocean Street for educational and outreach programming in partnership with OCEARCH pursuant to a lease authorized by Ordinance 2019-130-E.

Section 2. Further Authorizations. The Agreement include such additions, deletions and changes as may be reasonable, necessary and acceptable to the Mayor, or her designee, with such inclusion and acceptance being evidenced by execution of the Agreement by the Mayor, or her designee; provided however, no modification to the Agreement may increase the financial obligations or liability of the City to an amount in excess of the amount stated in the Agreement or decrease the duties and oblgiations of JU or OCEARCH as stated in the Agreement, and any such modifications shall be technical only and shall be subject to appropriate legal review and approval by the Office of General Counsel. For the purposes of this Ordinance, the term "technical changes" is defined as those changes having no financial impact to the City, changes required for compliance with the terms and conditions of the Submerged Land Lease, and any other non-substantive changes that do not substantively increase the duties and responsibilities of the City under the provisions of Agreement.

Section 3. Oversight Department. The Parks, Recreation and

Community Services Department shall oversee administration of the
Agreement and project described herein.

Section 4. Effective Date. This Ordinance shall become
effective upon signature by the Mayor or upon becoming effective
without the Mayor's signature.
