

NCSPPS AMENDMENT #13

The Neighborhoods, Community Services, Public Health and Safety Committee offers the following thirteenth amendment to File No. 2023-807:

- (1) On **page 3, lines 9-15** strike "APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO NEGOTIATE, EXECUTE, AND DELIVER AN AGREEMENT BETWEEN THE CITY AND RIVERFRONT PARKS CONSERVANCY, INC., A FLORIDA NON-PROFIT CORPORATION, ("RPC"), TO PLAN, DESIGN, AND CREATE A RESILIENT, UNIFIED RIVERWALK;";
- (2) On **page 4, lines 7-13**, strike "INVOKING THE EXCEPTION OF SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), *ORDINANCE CODE*, TO ALLOW FOR A DIRECT CONTRACT WITH RPC TO PLAN, DESIGN, AND CREATE A RESILIENT, UNIFIED RIVERWALK;";
- (3) On **page 5, lines 5-11**, strike "WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO ALLOW A DIRECT CONTRACT WITH RPC TO PLAN, DESIGN, AND CREATE A RESILIENT, UNIFIED RIVERWALK;";
- (4) On **page 7, line 16**, strike "Revised On File" and insert "Twelfth Revised On File";
- (5) On **page 13, lines 18-31 and page 14, lines 1-14**, strike Section 8 in its entirety;
- (6) Renumber the remaining Sections accordingly;
- (7) On **page 16, lines 14-23**, strike Section 13 in its entirety;
- (8) Renumber the remaining Sections accordingly;

- (9) On **page 18, lines 9-20, strike** Section 18 in its entirety;
- (10) Renumber the remaining Sections accordingly;
- (11) Remove **Revised On File** and replace with **Twelfth Revised On File**, attached hereto, which attaches the twelfth revised Mayor's Task Force Programs and Initiatives Summary to reflect that services related to the Riverfront Parks Conservancy initiative will be procured through a Request for Proposal process and to delete references to Riverfront Parks Conservancy and Exhibit 6;
- (12) Remove **Exhibit 6**;
- (13) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
