4 **ORDINANCE 2023-838-E**

5 AN ORDINANCE APPROPRIATING \$50,000.00 IN STATE  
6 GRANT FUNDING FROM THE STATE OF FLORIDA,  
7 DEPARTMENT OF STATE, DIVISION OF HISTORICAL  
8 RESOURCES TO FUND A SURVEY OF HISTORIC  
9 STRUCTURES WITHIN THE BOUNDARIES OF THE LOCALLY  
10 DESIGNATED SPRINGFIELD HISTORIC DISTRICT, AS  
11 INITIATED BY B.T. 24-026; PURPOSE OF  
12 APPROPRIATION; APPROVING AND AUTHORIZING THE  
13 MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
14 SECRETARY TO EXECUTE AND DELIVER A GRANT  
15 AGREEMENT WITH THE STATE OF FLORIDA, DEPARTMENT  
16 OF STATE, FOR THE PURPOSE OF PROVIDING THE GRANT  
17 FUNDS TO THE CITY; PROVIDING FOR OVERSIGHT BY  
18 THE PLANNING AND DEVELOPMENT DEPARTMENT;  
19 REQUESTING ONE-CYCLE EMERGENCY PASSAGE;  
20 PROVIDING AN EFFECTIVE DATE.

22 **BE IT ORDAINED** by the Council of the City of Jacksonville:

23 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
24 within the City's budget, there is hereby appropriated the indicated  
25 sum(s) from the account(s) listed in subsection (a) to the account(s)  
26 listed in subsection (b):

2 (c) Explanation of Appropriation:

3 The funding above represents an appropriation of state  
4 grants funds held in the Miscellaneous Grant Projects fund  
5 to conduct a survey of historic structures in the  
6 Springfield Historic District.

7 **Section 2. Purpose.** The purpose of the appropriation in  
8 Section 1 is to provide grant funding of \$50,000 to conduct a survey  
9 of historic structures in the Springfield Historic District. The  
10 scope of work includes procuring professional historic preservation  
11 services, conducting archival research, and conducting field surveys.

12 **Section 3. Approval of and authorization to enter Grant**  
13 **Agreement.** There is hereby approved, and the Mayor, or her designee,  
14 and the Corporation Secretary are hereby authorized to execute and  
15 deliver, the Grant Agreement between the City of Jacksonville and the  
16 State of Florida, Department of State, in substantially the same form  
17 as attached as **Exhibit 2** and incorporated herein by reference for the  
18 purposes of providing funds for the grant to the City and enabling  
19 the City to fund a survey of historic buildings in the Springfield  
20 Historic District.

21 **Section 4. Oversight.** The City of Jacksonville Planning  
22 and Development Department will provide oversight.

23 **Section 5. Requesting One-cycle Emergency Passage Pursuant**  
24 **to Council Rule 4.901 (Declaration of Emergency), Part 9 (Emergency**  
25 **Legislation), Chapter 4 (Procedures).** One-cycle emergency passage of  
26 this legislation is requested. The nature of the emergency is that  
27 pursuant to the terms of the grant, which was not received until  
28 September 12, 2023, the City must complete the historic survey by  
29 June 30, 2024. Time is of the essence to appropriate the grant funds

1 and commence work on the survey of historic buildings which will  
2 benefit historic preservation efforts in the City.

3           **Section 6.           Effective Date.**   This Ordinance shall become  
4 effective upon signature by the Mayor or upon becoming effective  
5 without the Mayor's signature.
