5 AN ORDINANCE APPROPRIATING \$98,005.00 FROM
6 AVAILABLE REVENUE BALANCE IN THE DOMESTIC
7 BATTERY SURCHARGE TRUST FUND (THE "FUND") TO
8 ESTABLISH THE FISCAL YEAR 2023-2024 OPERATING
9 BUDGET FOR THE FUND AND TO PROVIDE ADDITIONAL

15 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
16 within the City's budget, there is hereby appropriated the indicated

31 **Section 2. Purpose.** The purpose of the appropriation in

1 Section 1 is to establish the fiscal year 2023-2024 operating budget
2 for the Domestic Battery Surcharge Trust Fund. The funds will be
3 used to provide additional training to law enforcement personnel in
4 combating domestic violence. There are no requirements for a local
5 match, nor will there be additional staffing obligations or ongoing
6 maintenance costs associated with this appropriation.

7 **Section 3. Effective Date.** This Ordinance shall become
8 effective upon signature by the Mayor or upon becoming effective
9 without the Mayor's signature.
