4 **ORDINANCE 2024-**

5 AN ORDINANCE CONFIRMING THE APPOINTMENT OF
6 NICOLE HAMM, AS A MEMBER OF THE PUBLIC SERVICE
7 GRANT COUNCIL, WITH GRANT EXPERIENCE, REPLACING
8 DOGAN TOZOGLU, PURSUANT TO SECTION 80.102
9 (COMPOSITION; MEMBER QUALIFICATIONS; TERMS;
10 ANNUAL TRAINING REQUIREMENT; RESPONSIBILITIES),
11 CHAPTER 80 (PUBLIC SERVICE GRANT COUNCIL),
12 *ORDINANCE CODE*, FOR A FIRST TERM TO EXPIRE ON
13 DECEMBER 31, 2026; REQUESTING EMERGENCY PASSAGE
14 UPON INTRODUCTION; WAIVING COUNCIL RULE 4.1101
15 (APPEARANCE BEFORE COMMITTEE), *COUNCIL RULES*, AS
16 TO THE REQUIREMENT THAT THE APPOINTEE, PRIOR TO
17 CONFIRMATION, SHALL APPEAR BEFORE THE COMMITTEE
18 TO WHICH CONSIDERATION OF THE APPOINTMENT HAS
19 BEEN REFERRED; PROVIDING AN EFFECTIVE DATE.

21 **WHEREAS**, the initial grant process for the Public Service Grant
22 ("PSG") Council requires the attention and input of PSG members and
23 will begin imminently; and

24 **WHEREAS**, PSG Council members are needed to complete member
25 training, fill vacancies, appoint PSG officers and begin providing
26 their expertise to the PSG Council as expeditiously as possible; now
27 therefore

28 **BE IT RESOLVED** by the Council of the City of Jacksonville:

29 **Section 1. Appointment.** The Council hereby confirms the
30 Mayor's appointment of Nicole Hamm, a Duval County resident, to the
31 Public Service Grant Council, with grant experience, replacing Dogan

1 Tozoglu, pursuant to Section 80.102 (Composition; Member
2 Qualifications; Terms; Annual Training Requirement;
3 Responsibilities), Chapter 80 (Public Service Grant Council),
4 *Ordinance Code*, for a first full term to expire on December 31, 2026.

5 **Section 2. Requesting Emergency Passage Upon Introduction**
6 **pursuant to Council Rule 4.901 (Requesting Emergency Passage).**

7 Emergency passage upon introduction of this Ordinance is requested
8 to enable the appointee to participate in member training and to
9 participate meaningfully in the time-sensitive initial grant process
10 which begins imminently.

11 **Section 3. Waiver of Council Rule 4.1101 (Appearance Before**
12 **Committee), Council Rules.** Council Rule 4.1101 (Appearance Before
13 Committee), *Council Rules*, is hereby waived as to the requirement
14 that the appointee, prior to confirmation, be required to appear
15 before the committee to which consideration of the appointment has
16 been referred in order to facilitate the emergency passage of this
17 ordinance and maximize participation of PSG Council members in the
18 grant process.

19 **Section 4. Effective Date.** This Ordinance shall become
20 effective upon signature by the Mayor or upon becoming effective
21 without the Mayor's signature.
