## ORDINANCE 2024-110

AN ORDINANCE AMENDING THE JEA FISCAL YEAR 2022-2023 BUDGET; AMENDING ORDINANCE 2022-504-E (THE CITY OF JACKSONVILLE BUDGET ORDINANCE) BY AMENDING SCHEDULE C (JEA CONSOLIDATED OPERATING BUDGET) AND REVISED SCHEDULE D (JEA CONSOLIDATED CAPITAL BUDGET) TO APPROPRIATE SURPLUS FUNDS FROM FISCAL YEAR 2021-2022 AND EXCESS REVENUES IN THE ELECTRIC SYSTEM OPERATING BUDGET TO MAKE CONTRIBUTIONS TO THE NON-FUEL PURCHASED POWER RATE STABILIZATION FUND, TO APPROPRIATE THE REMAINING BALANCE WITHIN THE ENVIRONMENTAL -RATE STABILIZATION FUND TO INCREASE THE TRANSFER TO OPERATING CAPITAL OUTLAY IN THE WATER SYSTEM OPERATING BUDGET, TO APPROPRIATE THE ADDITIONAL TRANSFER FROM OPERATING CAPITAL OUTLAY AND ADDITIONAL OTHER PROCEEDS IN THE WATER SYSTEM CAPITAL BUDGET, AND TO APPROPRIATE EXCESS REVENUES IN THE DISTRICT ENERGY SYSTEM OPERATING BUDGET TO OPERATING CAPITAL OUTLAY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Ordinance 2022-504-E, which included the 2022-2023 Fiscal Year Operating and Capital Budgets for JEA, was enacted by Council on September 27, 2022; and

WHEREAS, Ordinance 2023-619-E was enacted by Council October 10, 2023, and increased the Capital Budget for the District Energy System by \$2,932,000 to fund additional capital projects and expenses; and

WHEREAS, a copy of Schedule C (JEA Consolidated Operating Budget) approved by Ordinance 2022-504-E and Revised Schedule D (JEA Consolidated Capital Budget) approved by Ordinance 2023-619-E are attached hereto as Exhibit 1; and

WHEREAS, on November 7, 2023, the JEA Board recommended amending Ordinance 2022-504-E to amend the fiscal year 2022-2023 JEA Consolidated Operating and Capital Budgets to appropriate additional revenues from the Electric and District Energy Systems and to allocate additional funds to Water System Capital Projects due to increased costs; and

WHEREAS, more specifically, the JEA Board authorized a net increase to the Electric System operating budget in the amount of \$60,040,239, an increase to the Water System capital budget in the amount of \$93,806,485, and an increase to the District Energy operating budget in the amount of \$9,062, as reflected in JEA Board Resolution 2023-44, attached hereto as Exhibit 2; and

WHEREAS, the increased expenses to the Electric System operating budget in the amount of \$60,040,239 are due to an increase of \$66,790,648 in the contribution to the Non-Fuel Purchased Power Rate Stabilization Fund which will fund future Plant Vogtle expenses by using \$40,294,302 from the Operating Fund carried over from fiscal year 2021-2022, \$13,354,661 in additional Investment Income, a net amount of \$6,391,276 in additional base Operating Revenues, all of which was offset by a net decrease in Non-Operating Expenses of \$6,750,409; and

WHEREAS, the increased expenses of \$26,643,922 for the Water System operating budget is due to an increase in the budgeted transfer to Operating Capital Outlay by using the remaining balance of the Environmental - Rate Stabilization Fund due to the elimination of the environmental fee; and

WHEREAS, the increased expenses of \$93,806,485 for the Water System capital budget are funded by the increased budget transfer of \$26,643,922 to Operating Capital Outlay and the use of additional Other Proceeds in the amount of \$67,162,563 funded by the use of debt proceeds; and

WHEREAS, the increased expenses for the District Energy System operating budget are due to an increase of \$9,062 in the budgeted transfer to Operating Capital Outlay by using net excess revenues in the current fiscal year; and

WHEREAS, the JEA Board authorized all of these amendments as more particularly described in the Inter-Office Memorandum dated November 7, 2023, attached hereto as Exhibit 3; and

WHEREAS, JEA is requesting the City Council approve this amendment to the JEA Consolidated Operating and Capital Budgets for fiscal year 2022-2023; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Amendment of Ordinance 2022-504-E to Revise Schedule C for the Fiscal Year 2022-2023 JEA Operating Budget and Revised Schedule D for the Fiscal Year 2022-2023 JEA Capital Budget. Sections 2.1 and 2.2 of Ordinance 2022-504-E are hereby amended, in part, to revise Schedules C and D to the JEA budget. The Revised Schedule C and the Second Revised Schedule D are attached hereto as Exhibit 4, and by this reference are made a part of Ordinance 2022-504-E.

Section 2. Effective Date. This Ordinance shall become effective upon signature by the Mayor, or upon becoming effective without the Mayor's signature.
