21 **BE IT RESOLVED** by the Council of the City of Jacksonville:

22 **Section 1. Appointment.** The Council hereby confirms the
23 Mayor's appointment of Michael Corbitt, a Duval County resident,
24 replacing Dr. Mary Jackson, to the KingSoutel Crossing Community
25 Redevelopment Agency Advisory Board, as a citizen member that lives
26 within one mile of the CRA boundary representing the general public,
27 pursuant to section 53.202 (Membership; appointment and removal;
28 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment
29 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency
30 Advisory Boards), *Ordinance Code*, for a first full term to expire on
31 December 31, 2025.

1 **Section 2. Effective Date.** This resolution shall become
2 effective upon signature by the Mayor or upon becoming effective
3 without the Mayor's signature.
