ORDINANCE 2024-157

AN ORDINANCE REGARDING CHAPTER 307 (HISTORIC PRESERVATION AND PROTECTION), ORDINANCE CODE; DESIGNATING THE PARCEL LOCATED IN COUNCIL DISTRICT 1 AT 0 ARLINGTON ROAD, BETWEEN WESTDALE DRIVE AND SPRINKLE DRIVE (R.E. NO. 141476-0000), OWNED BY THE CITY OF JACKSONVILLE, AS A LOCAL LANDMARK SITE; DIRECTING THECHIEF OF LEGISLATIVE SERVICES TO NOTIFY THE APPLICANT, THE PROPERTY OWNER, AND THE PROPERTY APPRAISER OF THE LOCAL LANDMARK SITE DESIGNATION, AND TO RECORD THE LOCAL LANDMARK SITE DESIGNATION IN THE OFFICIAL RECORDS OF DUVAL COUNTY; DIRECTING THE ZONING ADMINISTRATOR TO ENTER THE LOCAL LANDMARK SITE DESIGNATION ON THE ZONING ATLAS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Jacksonville City Council (the "Council") enacted Chapter 307 (Historic Preservation and Protection), Ordinance Code, to facilitate the designation of landmarks and landmark sites, where appropriate; and

WHEREAS, the parcel designated by this Ordinance is the site of a former outdoor pool of Norman Film Studios, located in Council District 1 at 0 Arlington Road, between Westdale Drive and Sprinkle Drive (R.E. No. 141476-0000), owned by the City of Jacksonville (the "Subject Property"); and

WHEREAS, the Subject Property, which was the location of an

outdoor swimming pool built for filming water scenes during Jacksonville's movie industry boom of the early 20th century, has been infilled and is not presently visible; and

WHEREAS, the outdoor pool is part of a larger complex of buildings that were utilized by the Eagle Film City and Norman Film Studios for early film production; and

WHEREAS, Jacksonville's history of film production began with a single film company in 1908, then from 1908 until 1922 thirty silent motion picture studios called Jacksonville home; and

WHEREAS, in 1916, the Eagle Film City established a silent motion picture company at the Subject Property, located in the Arlington neighborhood, but shortly thereafter, the Jacksonville movie industry began to decline due to a variety of local and national factors; and

WHEREAS, Richard E. Norman, Sr., one of the first independent movie producers to recognize the commercial potential of making black-cast movies specifically for an African-American audience, purchased the former Eagle Film City, including the Subject Property, in 1922; and

WHEREAS, Norman's films were some of the first to portray

African-Americans in a positive way; and

WHEREAS, after purchasing the former Eagle Film City, most of Norman's films were shot on location in Jacksonville and included many Arlington residents as background actors; and

WHEREAS, Norman is credited with being one of the first film producers to synchronize sound and motion to create early "talkies": movies made with speech and sound at a time when most films were silent; and

WHEREAS, pursuant to the requirements of Chapter 307 (Historic Preservation and Protection), Ordinance Code, the Council has considered the issue of designating the Subject Property as a landmark

site, taking into consideration its importance and historical value, as more fully set forth in the Designation Application, LM-23-09, and Staff Report of the Historic Preservation Section of the Planning and Development Department, a copy of which is **On File** with the Legislative Services Division and incorporated by reference herein (the "Application and Staff Report"); and

WHEREAS, all public notice and public hearing requirements have been met for designating the Subject Property as a local landmark site; and

WHEREAS, on January 24, 2024, the Jacksonville Historic Preservation Commission reviewed and recommended approval of the landmark site designation; and

WHEREAS, the property owner does not oppose the landmark site
designation; and

WHEREAS, having met the requisite criteria, the Council finds that it is in the best interest of the citizens of the City of Jacksonville to designate the Subject Property as a local landmark site, in furtherance of historic preservation and protection; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Designation of Local Landmark Site. Pursuant to Chapter 307 (Historic Preservation and Protection), Ordinance Code, the Council hereby designates the Subject Property, located in Council District 1 at 0 Arlington Road, between Westdale Drive and Sprinkle Drive (R.E. No. 141476-0000), as a local landmark site.

Section 2. Satisfaction of Requisite Criteria. The Council hereby finds that the Subject Property meets four of the requisite criteria set forth in Section 307.104(j), Ordinance Code, as more fully set forth in the Application and Staff Report. The four criteria are as follows:

Its value as a significant reminder of the cultural,

- 2. Its location is the site of a significant local, state or national event.
- 3. It is identified with a person or persons who significantly contributed to the development of the City, state or nation.
 - 4. Its suitability for preservation or restoration.

Section 3. Notice of Landmark Site Designation. Pursuant to Section 307.104(m), Ordinance Code, the Council hereby directs the Chief of Legislative Services, as designee of the Council Secretary, to notify the applicant, the property owner, and the Property Appraiser of the designation of the landmark site.

Section 4. Recording of Landmark Site Designation. The Council hereby directs the Chief of Legislative Services to record this Ordinance in the official records for Duval County, Florida.

Section 5. Landmark Site Designation on Zoning Atlas. Pursuant to Section 307.104(n), Ordinance Code, the Council hereby directs the Zoning Administrator, as designee of the Director of the Planning and Development Department, to enter the local landmark site designation on the Zoning Atlas, in accordance with Section 656.203, Ordinance Code.

Section 6. Effective Date. The enactment of this Ordinance shall be deemed to constitute a quasi-judicial action of the Council and therefore shall become effective upon signature by the Council President and Council Secretary.
