

## RULES AMENDMENT

The Rules Committee offers the following amendment to File No. 2024-73:

- (7) On **page 2, line 26**, after "2023." **insert** "Payment to Groundwork will be made upon the City's receipt of a final report at the conclusion of the Project.";
- (8) On **page 2, lines 27-29**, **strike** Section 3 in its entirety;
- (9) Renumber the remaining Sections accordingly;
- (10) On **page 3, line 4**, **strike** "of" and **insert** "or";
- (11) On **page 3, line 17**, **strike** "ordinance" and **insert** "Ordinance";
- (12) On **page 3, lines 18-22**, **strike** Section 5 in its entirety;
- (13) Renumber remaining Sections accordingly;
- (14) On **page 3, line 28**, **strike** "September 30, 2025" and **insert**

"Project completion";

- (15) Remove **Exhibit 1** and replace with **Revised Exhibit 1**, attached hereto, which attaches the second revised B.T. 24-054 to reflect the correct appropriation;
- (16) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
