This BT is necessary to appropriate \$250,000 in grant funds from Florida Department of Environmental Protection and \$250,000 in required City Match dollars, for planning and feasibility support for a shoreline enhancement project at Huguenot Memorial Park to address the critical issue of chronic erosion and ensure the protection of park infrastructure, neighboring communities, critical habitat, and visitor access. Deferral of this amendment until the next CIP would be detrimental to the City because it could result in the City losing valuable grant dollars.


