5 AN ORDINANCE APPROPRIATING \$18,429,138.41,  
6 INCLUDING (1) \$11,554,138.41 FROM THE PROJECTS  
7 TITLED MCCOY'S CREEK IMPROVEMENTS/PIPE REMOVAL,  
8 KERNAN BOULEVARD WIDEN - 4 LANES DVD - JTB AND  
9 MCCORMICK, HAMMOND BOULEVARD WALL, UNIVERSITY  
10 BOULEVARD AND JACK ROAD, SAN JOSE BOULEVARD -  
11 NEW, ST. JOHNS BLUFF ROAD - NEW SIDEWALK ES, ST.  
12 JOHNS BLUFF ROAD - NEW SIDEWALK WS, BISCAYNE  
13 BOULEVARD SIDEWALK - NEW AND EMERALD TRAIL - S-  
14 LINE CONNECTOR ("PRIOR PROJECTS") TO THE  
15 PROJECTS TITLED MCCOY'S CREEK GREENWAY - OUTFALL  
16 IMPROVEMENTS WITH RIVERWALK, PARK STREET ROAD  
17 DIET, MCCOY'S CREEK CHANNEL  
18 IMPROVEMENTS/RESTORATION, RANCH ROAD - DUVAL TO  
19 TRADEPORT - SIDEWALKS - MOBILITY DD, ARMSDALE  
20 ROAD - DUVAL ROAD IMPROVEMENTS, DUVAL ROAD  
21 IMPROVEMENTS - BETWEEN AIRPORT CENTER AND MAIN,  
22 AND EMERALD TRAIL MODEL MILE PROJECT  
23 ("PROJECTS") TO PAY FOR THE COMPLETION OF THE  
24 PROJECTS, AND (2) \$6,875,000 FROM THE AUTHORIZED  
25 CAPITAL PROJECTS FUND TO THE JTA TRANSPORTATION  
26 PROJECTS PAY-AS-YOU-GO FUND WITH RESPECT TO THE  
27 SHINDLER 103<sup>RD</sup> TO ARGYLE FOREST PROJECT  
28 ("SHINDLER PROJECT" AND TOGETHER WITH THE  
29 PROJECTS, THE "CIP PROJECTS"), AND UPDATING  
30 PRIOR APPROPRIATIONS TO REFLECT ACTUALS, AS  
31 INITIATED BY B.T. 24-065; AMENDING THE 2024-2028

1 FIVE-YEAR CAPITAL IMPROVEMENT PLAN APPROVED BY  
2 ORDINANCE 2023-505-E TO REFLECT THIS  
3 APPROPRIATION OF FUNDS TO THE CIP PROJECTS;  
4 PROVIDING FOR OVERSIGHT BY THE ENGINEERING AND  
5 CONSTRUCTION MANAGEMENT DIVISION OF THE  
6 DEPARTMENT OF PUBLIC WORKS; PROVIDING AN  
7 EFFECTIVE DATE.

9 **BE IT ORDAINED** by the Council of the City of Jacksonville:

10 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
11 within the City's budget, there is hereby appropriated the indicated  
12 sum(s) from the account(s) listed in subsection (a) to the account(s)  
13 listed in subsection (b):

20 (c) Explanation of Appropriation:

21 The funding above represents an appropriation of  
22 \$18,429,138.41, including (1) \$11,554,138.41 from the  
23 projects titled McCoy's Creek Improvements/Pipe Removal,  
24 Kernan Boulevard Widen - 4 Lanes DVD - JTB and McCormick,  
25 Hammond Boulevard Wall, University Boulevard and Jack Road,  
26 San Jose Boulevard - New, St. Johns Bluff Road - New  
27 Sidewalk ES, St. Johns Bluff Road - New Sidewalk WS,  
28 Biscayne Blvd Sidewalk - New and Emerald Trail - S-Line  
29 Connector (the "Prior Projects") to the projects titled  
30 McCoy's Creek Greenway - Outfall Improvements with  
31 Riverwalk, Park Street Road Diet, McCoy's Creek Channel

1           Improvements/Restoration, Ranch Road - Duval to Tradeport  
2           - Sidewalks - Mobility DD, Armsdale Road - Duval Road  
3           Improvements, Duval Road Improvements - Between Airport  
4           Center and Main, and Emerald Trail Model Mile ("Projects")  
5           to provide funding to complete projects which include  
6           various stormwater and drainage improvements, intersection  
7           and roadway improvements, and the design and construction  
8           of multi-use paths and sidewalks, and (2) \$6,875,000 from  
9           the Authorized Capital Projects Fund to the JTA  
10          Transportation Projects Pay-As-You-Go Fund with respect to  
11          the Shindler 103<sup>rd</sup> to Argyle Forest project ("Shindler  
12          Project" and together with the Projects, the "CIP  
13          Projects"), and also updating prior appropriations to  
14          reflect actuals.

15           **Section 2.           Purpose.**    The purpose of the appropriation in  
16          Section 1 is to allocate funds from the Prior Projects to the Projects  
17          and transfer \$6,875,000 between funds with respect to the Shindler  
18          103<sup>rd</sup> to Argyle Forest project ("Shindler Project" and together with  
19          the Projects, the "CIP Projects").    The McCoy's Creek Greenway -  
20          Outfall Improvements with Riverwalk project includes stormwater  
21          improvements from Myrtle Avenue to the outfall and other improvements  
22          to increase access and recreational opportunity associated with  
23          McCoy's Creek and the adjacent riverfront park.    The Park Street Road  
24          Diet project includes modifications to existing roadway  
25          infrastructure from Forest Street to Stonewall Street within the  
26          Brooklyn Neighborhood to enhance pedestrian and bicycle connectivity  
27          and improve vehicular safety.        The McCoy's Creek Channel  
28          Improvements/Restoration project includes drainage improvements to  
29          McCoy's Creek between Hollybrook and Myrtle Avenue.    The Ranch Road -  
30          Duval to Tradeport - Sidewalks - Mobility DD includes the construction  
31          of new sidewalks on Ranch Road from Duval Place to Tradeport Drive.

1 The Armsdale Road - Duval Road Improvements project includes  
2 intersection improvements at Duval Road and Armsdale Road and related  
3 improvements along certain portions of Armsdale Road and Duval Road,  
4 including sidewalks, curve warning enhancements, a pedestrian  
5 crossing and drainage. The Duval Road Improvements - between Airport  
6 Center and Main project includes improvements of Duval Road from  
7 Airport Road to Biscayne Boulevard. The Emerald Trail Model Mile  
8 project includes the design and construction of a multi-use path  
9 connecting the south end of the existing S-Line trail to the  
10 intersection of Park Street and Stonewall Street, including mid-block  
11 crossings to help connect surrounding neighborhoods and other  
12 recreational amenities with a pedestrian friendly walkway, and  
13 modifying the Park Street viaduct to connect the Park Street Road  
14 Diet project. The Shindler Project provides for two phases which  
15 include a four-lane urban section from Argyle Forest Boulevard to  
16 Sugartree and a three-lane urban section from Sugartree to Collins  
17 Road as well as a three-lane urban section from Collins Road to 103rd  
18 Street. The Prior Projects have been completed and this reallocation  
19 of funds and appropriation is necessary to allow for the completion  
20 of the CIP Projects. In addition, the appropriation updates prior  
21 appropriations to reflect actuals.

22 **Section 3. Capital Improvement Plan Amendment.** Ordinance  
23 2023-505-E, adopting the 2024-2028 Five-Year Capital Improvement Plan  
24 (the "CIP") for the City and certain of its independent agencies, is  
25 hereby amended to appropriate funds to the CIP Projects as more fully  
26 described in the Project Information Sheets attached hereto as **Exhibit**  
27 **2**, and incorporated herein by this reference. The City Council finds  
28 that the deferral of this amendment of the CIP until the next annual  
29 budget and CIP review will be detrimental to the best interests of  
30 the community because such deferral will unnecessarily delay  
31 completion of the CIP Projects.

1 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of  
2 this Ordinance requires the affirmative vote of two-thirds of the  
3 City Council members present at the meeting because of the CIP  
4 amendment set forth in this section. This Ordinance shall constitute  
5 an amendment to Ordinance 2023-505-E. In all other respects, the  
6 Five-Year Capital Improvement Plan approved by Ordinance 2023-505-E  
7 shall remain unchanged and continue in full force and effect.

8 **Section 4. Oversight.** The Engineering and Construction  
9 Management Division of the Department of Public Works shall have  
10 oversight in the projects described herein.

11 **Section 5. Effective Date.** This Ordinance shall become  
12 effective upon signature by the Mayor or upon becoming effective  
13 without the Mayor's signature.
