22 **BE IT RESOLVED** by the Council of the City of Jacksonville:

23 **Section 1. Appointment.** The Council hereby confirms the  
24 Mayor's appointment of Michael Corbitt, a Duval County resident,  
25 replacing Dr. Mary Jackson, to the KingSoutel Crossing Community  
26 Redevelopment Agency Advisory Board, as a citizen member that lives  
27 within one mile of the CRA boundary representing the general public,  
28 pursuant to section 53.202 (Membership; appointment and removal;  
29 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment  
30 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency  
31 Advisory Boards), *Ordinance Code*, for a first full term to expire on

1 December 31, 2025.

2           **Section 2.           Effective Date.**   This Resolution shall become  
3 effective upon signature by the Mayor or upon becoming effective  
4 without the Mayor's signature.
