Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for the remodeling, build-out and furnishing of a section of the first floor of the Yates Building, which is the Main Branch of the Duval County Tax Collector. This area on the first floor will be remodeled into a reception and waiting area, will provide a secure drop-off locker solution for car dealers and will create a Title Services Office.
