6 AN ORDINANCE CONFIRMING THE APPOINTMENT OF  
7 CORETTA HILL, A ST. JOHNS COUNTY RESIDENT, AS A  
8 MEMBER OF THE CULTURAL SERVICE GRANT PROGRAM  
9 COMMITTEE, AS ONE OF THE SEVEN COMMUNITY  
10 REPRESENTATIVES, REPLACING WILTON BLAKE,  
11 PURSUANT TO SECTION 118.605, *ORDINANCE CODE*, FOR  
12 A FIRST FULL TERM EXPIRING DECEMBER 31, 2026;  
13 ESTABLISHING SUBSTANTIAL ECONOMIC BUSINESS  
14 INTEREST IN DUVAL COUNTY, PURSUANT TO SECTION  
15 50.102(B) (RESIDENCY REQUIREMENT) (MEMBERS OF  
16 BOARDS AND COMMISSIONS), PART 1 (ORGANIZATION),  
17 CHAPTER 50 (ORGANIZATION OF BOARDS AND  
18 COMMISSIONS), *ORDINANCE CODE*; PROVIDING AN  
19 EFFECTIVE DATE.

21 **WHEREAS**, pursuant to Section 118.605(a), *Ordinance Code*, the  
22 membership of the Cultural Service Grant Program Committee shall  
23 include one non-voting and ten voting members: a CSGP Committee  
24 chairperson (non-voting), appointed by the President of the Cultural  
25 Council Board of Directors; three other Cultural Council Board members  
26 selected by the Board President and Committee Chairperson; and seven  
27 individuals selected by the above group (Cultural Council Board  
28 President, CSGP Committee chairperson, and three selected Cultural  
29 Council Board members); and

30 **WHEREAS**, pursuant to Section 118.605(d), *Ordinance Code*, all  
31 members of the Cultural Service Grant Program Committee shall be

1 confirmed by the City Council; now therefore

2 **BE IT ORDAINED** by the Council of the City of Jacksonville:

3 **Section 1. Confirmation.** The Council hereby confirms the  
4 appointment of Coretta Hill, a St. Johns County resident, to the  
5 Cultural Service Grant Program Committee, replacing Wilton Blake, as  
6 one of the seven community representatives, pursuant to Section  
7 118.605, *Ordinance Code*, for a first full term expiring December 31,  
8 2026.

9 **Section 2. A Non-Resident of Duval County with Substantial**  
10 **Economic Business Interests in Duval County.** Section 50.102 (Members  
11 of Boards and Commissions), Part 1 (Organization), Chapter 50  
12 (Organization of Boards and Commissions), *Ordinance Code*, requires  
13 Board and Commission members be either a Duval Country resident or  
14 individuals with substantial economic business interest or  
15 substantial philanthropic interest in Duval County. Ms. Hill has  
16 substantial economic business interests in Duval County. She is the  
17 Chief Operating Officer for United Way of Northeast Florida, and  
18 previously served as United Way Vice President of Volunteer and  
19 Community Engagement for more than a decade. United Way of Northeast  
20 Florida is in the Jessie Ball duPont Center located at 40 East Adams  
21 Street, Jacksonville, Florida 32202.

22 **Section 3. Effective Date.** This Ordinance shall become  
23 effective upon signature by the Mayor or upon becoming effective  
24 without the Mayor's signature.
