5 A RESOLUTION CONFIRMING THE APPOINTMENT OF
6 TAMEKA GAINES HOLLY, A RESIDENT AND QUALIFIED
7 ELECTOR OF THE CITY OF JACKSONVILLE, AS A JEA
8 REPRESENTATIVE, TO THE CIVIL SERVICE BOARD,
9 REPLACING GERALDINE (LOCKETT) JACKSON, PURSUANT
10 TO SECTION 17.02 (CIVIL SERVICE BOARD), ARTICLE
11 17 (CIVIL SERVICE), *CHARTER OF THE CITY OF*
12 *JACKSONVILLE*, FOR A FIRST FULL TERM TO EXPIRE ON
13 JUNE 30, 2026; PROVIDING AN EFFECTIVE DATE.

15 **WHEREAS**, Section 17.02(b), as amended, of the Charter of the
16 City of Jacksonville, Laws of Florida, requires JEA to appoint two
17 members to the Civil Service Board; and

18 **WHEREAS**, the JEA Board approved the appointment of Tameka Gaines
19 Holly to the Civil Service Board by resolution on January 30, 2024,
20 a copy of the JEA resolution is attached hereto as **Exhibit 1**; and

21 **WHEREAS**, pursuant to Section 17.02(b), as amended, of the
22 Charter of the City of Jacksonville, Laws of Florida, appointments
23 to the Civil Service Board are required to be approved by the City
24 Council; now therefore

25 **BE IT RESOLVED** by the Council of the City of Jacksonville:

26 **Section 1. Confirmation of Appointment.** The Council does hereby
27 confirm the appointment of Tameka Gaines Holly, a resident and
28 qualified elector of the City of Jacksonville, as a JEA
29 representative, to the Civil Service Board, replacing Geraldine
30 (Lockett) Jackson, pursuant to Section 17.02 (Civil Service Board),
31 Article 17 (Civil Service), *Charter of the City of Jacksonville*, for

1 a first full term to expire on June 30, 2026. Attached hereto as
2 **Exhibit 2** is the curriculum vitae of Tameka Gaines Holly.

3 **Section 2. Effective Date.** This resolution shall become
4 effective upon signature by the Mayor or upon becoming effective
5 without the Mayor's signature.
