6 COUNCIL PRESIDENT’S DESIGNATED CONTINGENCY TO
7 THE PUBLIC SERVICE GRANT (“PSG”) MICRO-GRANT
8 PROGRAM SUBSIDIES AND CONTRIBUTIONS TO PRIVATE
9 ORGANIZATIONS ACCOUNT TO FUND THE PSG
10 MICRO-GRANT PROGRAM MOST VULNERABLE PERSONS AND
11 NEEDS CATEGORY FOR FISCAL YEAR 2024-2025, AS
12 APPROVED BY ORDINANCE 2024-198-E; PROVIDING FOR
13 CARRYOVER TO FISCAL YEAR 2024-2025; PROVIDING AN
14 EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
18 within the City’s budget, there is hereby appropriated the indicated

28 The funding above is an appropriation of \$200,000 from the
29 Council President’s Designated Contingency to the Public
30 Service Grant (“PSG”) Micro-Grant Program Subsidies and
31 Contributions to Private Organizations account to fund the

1 PSG Micro-Grant Program Most Vulnerable Persons and Needs
2 category for fiscal year 2024-2025 as approved by Ordinance
3 2024-198-E.

4 **Section 2. Purpose.** The purpose of the appropriation in
5 Section 1 is to provide funding to the Public Service Grant ("PSG")
6 Council to fund the Micro-Grant Program Most Vulnerable Persons and
7 Needs category for fiscal year 2024-2025. This category was originally
8 established by Ordinance 2022-214-E. The City Council has approved a
9 continuation of the Micro-Grant Program for fiscal year 2024-2025 as
10 outlined in Ordinance 2024-198-E.

11 **Section 3. Carryover.** The funds appropriated herein shall
12 not lapse but shall carryover to fiscal year 2024-2025.

13 **Section 4. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
