7 A RESOLUTION CONFIRMING THE JACKSONVILLE ETHICS
8 COMMISSION'S REAPPOINTMENT OF KIRBY G.
9 OBERDORFER, A REGISTERED DUVAL COUNTY VOTER, AS
10 THE DIRECTOR OF THE OFFICE OF ETHICS, COMPLIANCE
11 AND OVERSIGHT (ECO) FOR THE CITY OF
12 JACKSONVILLE, PURSUANT TO SECTION 602.612,
13 *ORDINANCE CODE*, FOR A THREE-YEAR TERM ENDING
14 SEPTEMBER 30, 2027; PROVIDING FOR A PROSPECTIVE
15 EFFECTIVE DATE; PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, on June 1, 2021, the Jacksonville Ethics Commission
18 voted to appoint Kirby G. Oberdorfer to serve as the next City of
19 Jacksonville's Director of the Office of Ethics, Compliance and
20 Oversight, and this appointment was confirmed by Council through
21 Resolution 2021-359-A; and

22 **WHEREAS**, on June 17, 2024, the Jacksonville Ethics Commission
23 voted to reappoint Kirby G. Oberdorfer to serve as the City of
24 Jacksonville's Director of the Office of Ethics, Compliance and
25 Oversight, a copy of the Resolution of the Jacksonville Ethics
26 Commission reappointing Ms. Oberdorfer as Ethics Director for a second
27 3-year term is attached hereto as **Exhibit 1**; now therefore

28 **BE IT RESOLVED** by the Council of the City of Jacksonville:

29 **Section 1. Council Confirmation.** The Council hereby
30 confirms the Jacksonville Ethics Commission's reappointment of Kirby
31 G. Oberdorfer, a registered Duval County voter, as the City of

1 Jacksonville's Director of the Office of Ethics, Compliance and
2 Oversight, pursuant to Section 602.612, *Ordinance Code*, for an
3 additional three-year term ending on September 30, 2027.

4 **Section 2. Prospective Effective Date.** This appointment
5 shall become effective October 1, 2024, as her current term as
6 Director of the Office of Ethics, Compliance and Oversight is
7 effective through September 30, 2024.

8 **Section 3. Effective Date.** This Resolution shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
