11 FROM THE FORECLOSURE REGISTRY IN THE AMOUNT OF
12 \$311,995.85, TO FUND VARIOUS PROGRAMS AND
13 ACTIVITIES AUTHORIZED PURSUANT TO CHAPTER 179,
14 *ORDINANCE CODE*, AS INITIATED BY REVISED B.T.
15 24-080; AUTHORIZING POSITIONS, AS INITIATED BY
16 R.C. 24-119; PROVIDING AN EFFECTIVE DATE.

19 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
20 within the City's budget, there are hereby appropriated the
21 indicated sum(s) from the account(s) listed in subsection (a) to
22 the account(s) listed in subsection (b):

31 The funding above comprises \$498,313.88 in revenue

1 collected from the Foreclosure Registry and a
2 reallocation of previously appropriated funds in the
3 amount of \$311,995.85 to fund various programs and
4 activities authorized pursuant to Chapter 179, *Ordinance*
5 *Code*.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to move revenue actuals and also provide funding for
8 various programs and activities authorized pursuant to Chapter 179,
9 *Ordinance Code*. The funds are collected from mortgagees on
10 properties that are in default.

11 **Section 3. Approval of Positions.** There are hereby
12 approved the positions more fully described in R.C. 24-119,
13 attached hereto as **Exhibit 2** and incorporated herein by this
14 reference.

15 **Section 4. Effective Date.** This Ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
