5 AN ORDINANCE REGARDING OPIOID AND SUBSTANCE USE
6 DISORDER SETTLEMENT PROCEEDS GRANTS;
7 APPROPRIATING \$4,768,478 FROM THE OPIOID
8 SETTLEMENT FUND - MISCELLANEOUS SETTLEMENTS
9 ACCOUNT TO THE OPIOID SETTLEMENT FUND -
10 SUBSIDIES AND CONTRIBUTIONS TO PRIVATE
11 ORGANIZATIONS ACCOUNT TO FUND OPIOID AND
12 SUBSTANCE USE DISORDER SETTLEMENT PROCEEDS
13 GRANTS ("OSUD GRANTS"); PROVIDING FOR CITY
14 OVERSIGHT BY THE OPIOID ABATEMENT MANAGER WITHIN
15 THE JACKSONVILLE FIRE AND RESCUE DEPARTMENT;
16 WAIVING THE CONFLICTING PROVISION OF SECTION
17 84.301 (OPIOID SETTLEMENT PROCEEDS ALLOCATION
18 FOR OPIOID SETTLEMENT PROCEEDS GRANTS), PART 3
19 (OPIOID SETTLEMENT PROCEEDS GRANT AWARD
20 PROCEDURES), CHAPTER 84 (OPIOID SETTLEMENT
21 PROCEEDS GRANTS), *ORDINANCE CODE*, TO APPROVE THE
22 LUMP SUM APPROPRIATION FOR OSUD GRANTS BY
23 SEPARATE LEGISLATION FROM THE ANNUAL BUDGET
24 ORDINANCE; PROVIDING AN EFFECTIVE DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
28 within the City's budget, there are hereby appropriated the indicated
29 sum(s) from the account(s) listed in subsection (a) to the account(s)
30 listed in subsection (b):

6 (c) Explanation of Appropriation:

7 The funding above is an appropriation from the designated
8 Opioid Settlement Fund - Miscellaneous Settlements account
9 to the Opioid Settlement Fund - Subsidies and Contributions
10 to Private Organizations account to fund Opioid and
11 Substance Use Disorder Settlement Proceeds Grants ("OSUD
12 Grants").

13 **Section 2. Purpose.** The OSUD Grant appropriation shall be
14 allocated to the Prevention (34%), Treatment (33%) and Recovery
15 Support (33%) categories as outlined and approved in Ordinance
16 2024-251-E, shall be used solely for the purpose of the listed Opioid
17 and Substance Use Disorder Settlement Proceeds Grant categories and
18 may not be transferred or reallocated for any other utilization within
19 the respective department. OSUD Grants are subject to the provisions
20 of Chapter 84, *Ordinance Code*. The appropriation made herein shall
21 be awarded as grants-in-aid to miscellaneous agencies and shall not
22 require additional legislation for distribution of funds. Pursuant
23 to Section 118.808, *Ordinance Code*, the Opioid and Substance Use
24 Disorder Grants Committee shall forward a complete list of the OSUD
25 Grants recipients and funding allocations to the Council Auditor's
26 Office, the Office of the Mayor, the City Council, and the Director
27 of the Finance Department.

28 **Section 3. Oversight.** The Manager of Opioid Abatement
29 within the Jacksonville Fire and Rescue Department shall oversee the
30 grants described herein.

31 **Section 4. Waiving Conflicting Provision of Section 84.301,**

1 **Ordinance Code.** The conflicting provision of Section 84.301 (Opioid
2 Settlement Proceeds Allocation for Opioid Settlement Proceeds
3 Grants), Part 3 (Opioid Settlement Proceeds Grant Award Procedures),
4 Chapter 84 (Opioid Settlement Proceeds Grants), *Ordinance Code*,
5 requiring this appropriation to be included in the Mayor's annual
6 budget is hereby waived. Waiver of Section 84.301, *Ordinance Code*,
7 is necessary because the OSUD Grant lump sum appropriation for the
8 2024-2025 annual budget will be considered and acted upon by Council
9 by this Ordinance 2024-510 and not in the annual budget Ordinance
10 2024-504.

11 **Section 5. Effective Date.** This Ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
