5 A RESOLUTION CONFIRMING THE MAYOR’S APPOINTMENT
6 OF SHANTEL N. DAVIS, A ST. JOHNS COUNTY
7 RESIDENT, AS A MEMBER OF THE HOMELESSNESS
8 INITIATIVES COMMISSION, PURSUANT TO SECTION
9 86.103 (COMPOSITION; LIAISONS; TERMS; REMOVAL),
10 CHAPTER 86 (HOMELESSNESS INITIATIVES
11 COMMISSION), *ORDINANCE CODE*, FOR A FIRST FULL
12 TERM ENDING FEBRUARY 28, 2027; ESTABLISHING
13 SUBSTANTIAL PHILANTHROPIC INTEREST IN DUVAL
14 COUNTY, PURSUANT TO SECTION 50.102(B) (MEMBERS
15 OF BOARDS AND COMMISSIONS), PART 1
16 (ORGANIZATION), CHAPTER 50 (ORGANIZATION OF
17 BOARDS AND COMMISSIONS), *ORDINANCE CODE*;
18 REQUESTING ONE CYCLE EMERGENCY PASSAGE;
19 PROVIDING AN EFFECTIVE DATE.

21 **BE IT RESOLVED** by the Council of the City of Jacksonville:

22 **Section 1. Confirmation.** The City Council hereby confirms
23 the Mayor’s appointment of Shantel N. Davis, a St. Johns County
24 resident, to the Homelessness Initiatives Commission, pursuant to
25 Section 86.103 (Composition; Liaisons; Terms; Removal), Chapter 86
26 (Homelessness Initiatives Commission), *Ordinance Code*, for a first
27 full term ending February 28, 2027.

28 **Section 2. Establishing Substantial Philanthropic Interest**
29 **in Duval County.** Section 50.102(b) (Members of boards and
30 commissions), Part 1 (Organization), Chapter 50 (Organization of
31 Boards and Commissions), *Ordinance Code*, requires Board and

1 Commission members be either permanent residents of Duval County or
2 to maintain substantial economic business or philanthropic interest
3 as determined by the City Council within Duval County. In this
4 instance, although the appointee does not reside within Duval County,
5 Ms. Davis currently serves in leadership roles for several non-profit
6 and philanthropic organizations based in and serving Duval County,
7 including serving as a board member for the following organizations:
8 Jacksonville University Public Policy, Jacksonville Classical
9 Academy, First Coast YMCA Metro, Goodwill of Northeast Florida, and
10 the University of North Florida Foundation.

11 **Section 3. Requesting One Cycle Emergency Passage Pursuant**
12 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
13 legislation is requested. The nature of the emergency is that the
14 Committee requires appointees as soon as possible to begin addressing
15 the significant issues presented by Duval County's homeless and
16 chronically unhoused populations.

17 **Section 4. Effective Date.** This Resolution shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
