4 **ORDINANCE 2024-601**

5 AN ORDINANCE APPROPRIATING \$3,887,768.41,  
6 INCLUDING CURRENT YEAR SAVINGS OF \$2,617,435.34  
7 FROM THE MAYOR’S CURE VIOLENCE PROGRAM (THE  
8 “PROGRAM”) AND \$1,270,333.07 FROM GENERAL FUND  
9 OPERATING FUND BALANCE RELATED TO THE CLOSEOUT  
10 OF PRIOR YEAR FUNDING FOR THE PROGRAM, TO  
11 PROVIDE \$2,887,768.41 TO SPECIAL COUNCIL  
12 CONTINGENCY ACCOUNT TO BE USED FOR CITY COUNCIL  
13 STRATEGIC INITIATIVES IN FISCAL YEAR 2024-2025  
14 AND \$1,000,000.00 TO A COUNCIL PRESIDENT  
15 CONTINGENCY ACCOUNT; PROVIDING FOR CARRYOVER TO  
16 FISCAL YEAR 2024-2025; REQUESTING ONE CYCLE  
17 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2023-2024 fiscal year,  
21 within the City’s budget, there is hereby appropriated the indicated  
22 sum(s) from the account(s) listed in subsection (a) to the account(s)  
23 listed in subsection (b):

30 (c) Explanation of Appropriation:  
31 The funding above is an appropriation of \$3,887,768.41,

1 including current year savings of \$2,617,435.34 from the  
2 Mayor's Cure Violence Program (the "Program") and  
3 \$1,270,333.07 from General Fund Operating fund balance  
4 related to the closeout of prior year funding for the  
5 Program, to provide \$2,887,768.41 to a Special Council  
6 Contingency account to be used for City Council Strategic  
7 Initiatives in Fiscal Year 2024-2025 and \$1,000,000.00 to  
8 a Council President Contingency account.

9 **Section 2. Purpose.** The purpose of the appropriation in  
10 Section 1 is to use remaining dollars from the Program in Fiscal Year  
11 2023-2024 and General Fund dollars to provide \$2,886,768.41 to fund  
12 a portion of the City Council Strategic Initiatives for Fiscal Year  
13 2024-2025 as outlined in Ordinance 2024-164-E and \$1,000,000.00 to  
14 fund a variety of initiatives in Fiscal Year 2024-2025.

15 **Section 3. Carryover.** The funds appropriated herein shall  
16 not lapse but shall carryover to fiscal year 2024-2025.

17 **Section 4. Requesting One Cycle Emergency Passage Pursuant**  
18 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
19 legislation is requested. The nature of the emergency is to allow  
20 the Council to deliberate and take action on this appropriation  
21 contemporaneously with the Finance Committee commencing its review  
22 of the Fiscal Year 2024-2025 budget. During the budget review, the  
23 Finance Committee is expected to discuss and make recommendations  
24 regarding the Fiscal Year 2024-2025 City Council Strategic  
25 Initiatives and other Council initiatives that are proposed to be  
26 funded by this appropriation.

27 **Section 5. Effective Date.** This Ordinance shall become  
28 effective upon signature by the Mayor or upon becoming effective  
29 without the Mayor's signature.
