The purpose of this legislation is to seek approval from the City Council to appropriate \$3,781,211.73 of funds previously appropriated for Cure Violence.

The Grants and Contract Compliance Division has been diligently working to close out Cure Violence contracts that expired January 31, 2024 and has identified \$1,427,876.73 in unspent funds for prior Cure Violence contracts. When closing out these purchase orders, these funds will drop to fund balance; therefore, this request involves a transfer from fund balance. There is also \$2,353,335.00 in a contingency account appropriated in the FY24 for Cure Violence in the event we chose to extend the contracts beyond January 31, 2024. This funding represents seed money for the Journey Forward strategic initiative. The legislation will also include a request for carryover language as all such monies would be swept absent this request. Upon the appointment of the oversight board, and the completion of a strategic plan to guide the programmatic work, the oversight board will propose operating funding requests to Mayor Deegan for inclusion in her future budgets that she will present to the City Council for review and approval.


