8 A RESOLUTION CONFIRMING THE JACKSONVILLE ETHICS  
9 COMMISSION'S REAPPOINTMENT OF KIRBY G.  
10 OBERDORFER, A REGISTERED DUVAL COUNTY VOTER, AS  
11 THE DIRECTOR OF THE OFFICE OF ETHICS, COMPLIANCE  
12 AND OVERSIGHT (ECO) FOR THE CITY OF  
13 JACKSONVILLE, PURSUANT TO SECTION 602.612,  
14 *ORDINANCE CODE*, FOR A THREE-YEAR TERM ENDING  
15 SEPTEMBER 30, 2027; PROVIDING FOR A PROSPECTIVE  
16 EFFECTIVE DATE; PROVIDING AN EFFECTIVE DATE.

18 **WHEREAS**, on June 1, 2021, the Jacksonville Ethics Commission  
19 voted to appoint Kirby G. Oberdorfer to serve as the next City of  
20 Jacksonville's Director of the Office of Ethics, Compliance and  
21 Oversight, and this appointment was confirmed by Council through  
22 Resolution 2021-359-A; and

23 **WHEREAS**, on June 17, 2024, the Jacksonville Ethics Commission  
24 voted to reappoint Kirby G. Oberdorfer to serve as the City of  
25 Jacksonville's Director of the Office of Ethics, Compliance and  
26 Oversight, a copy of the Resolution of the Jacksonville Ethics  
27 Commission reappointing Ms. Oberdorfer as Ethics Director for a second  
28 3-year term is attached hereto as **Exhibit 1**; now therefore

29 **BE IT RESOLVED** by the Council of the City of Jacksonville:

30 **Section 1. Council Confirmation.** The Council hereby  
31 confirms the Jacksonville Ethics Commission's reappointment of Kirby

1 G. Oberdorfer, a registered Duval County voter, as the City of  
2 Jacksonville's Director of the Office of Ethics, Compliance and  
3 Oversight, pursuant to Section 602.612, *Ordinance Code*, for an  
4 additional three-year term ending on September 30, 2027.

5 **Section 2. Prospective Effective Date.** This appointment  
6 shall become effective October 1, 2024, as her current term as  
7 Director of the Office of Ethics, Compliance and Oversight is  
8 effective through September 30, 2024.

9 **Section 3. Effective Date.** This Resolution shall become  
10 effective upon signature by the Mayor or upon becoming effective  
11 without the Mayor's signature.
