4 **ORDINANCE 2024-733**

5 AN ORDINANCE AMENDING THE 2024-2028 FIVE-YEAR IT
6 SYSTEM DEVELOPMENT PLAN APPROVED BY ORDINANCE
7 2023-507-E TO EXPAND SCOPE OF THE WI-FI IN THE
8 COJ PARKS PROJECT FROM SPECIFIC ZIP CODES TO A
9 COUNTYWIDE BASIS; PROVIDING FOR OVERSIGHT BY THE
10 TECHNOLOGY SOLUTIONS DEPARTMENT; PROVIDING AN
11 EFFECTIVE DATE.

13 **WHEREAS**, the City is currently implementing Wi-Fi access in City
14 parks primarily serving the underserved areas and located within the
15 32206, 32208, 32209, 32210, 32211, 32244 and 32254 zip codes; and

16 **WHEREAS**, the City has determined that it is in the best interest
17 of the City to expand this project to City parks on a countywide
18 basis; and

19 **WHEREAS**, notwithstanding the foregoing expansion, the project
20 will continue to focus on Wi-Fi access in the City parks located
21 within the 32206, 32208, 32209, 32210, 32211, 32244 and 32254 zip
22 codes; now therefore

23 **BE IT ORDAINED** by the Council of the City of Jacksonville:

24 **Section 1. Recitals.** The recitals above are incorporated
25 herein by this reference.

26 **Section 2. Amending the 2024-2028 Five-Year IT System**
27 **Development Plan Approved by Ordinance 2023-507-E.** The 2024-2028
28 Five-Year IT System Development Plan, approved by Ordinance 2023-507-
29 E, as amended by Ordinances 2023-807-E, 2023-880-E, and 2024-394-E
30 is hereby amended by substituting in the place of Exhibit 1 to
31 Ordinance 2023-507-E, the Fiscal Year 2024-2028 IT System Development

1 Projects schedule, attached hereto as **Exhibit 1**, and incorporated
2 herein by this reference. Ordinance 2023-507-E, as amended by
3 Ordinances 2023-807-E, 2023-880-E, and 2024-394-E is hereby further
4 amended by replacing the Wi-Fi Expansion - City Parks project page
5 with the Wi-Fi Expansion - County-wide Parks project page attached
6 hereto as **Exhibit 2**, and incorporated herein by this reference, as
7 part of Exhibit 2 to Ordinance 2023-507-E.

8 **Section 3. Oversight.** The Department of Technology
9 Solutions shall oversee the project described herein.

10 **Section 4. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
