19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
21 within the City's budget, there are hereby appropriated the indicated
22 sum(s) from the account(s) listed in subsection (a) to the account(s)
23 listed in subsection (b):

31 (c) **Explanation of Appropriation** - The funding above represents

1 Supervisor of Elections fund balance and remaining
2 investment pool earnings generated from the Help America
3 Vote Act (HAVA) grant from the U.S. Election Assistance
4 Commission through the State of Florida, Department of
5 State, Division of Elections, and will be used for election
6 education and for building and security improvements.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to appropriate Supervisor of Elections fund balance and
9 remaining investment pool earnings generated from the Help America
10 Vote Act (HAVA) grant to provide funding to the City for election
11 education and to make building and security upgrades and/or
12 enhancements. The State of Florida, Department of State, Division of
13 Elections, has requested that all remaining funds related to the HAVA
14 grant program be used to close out the program.

15 **Section 3. Carryover.** The funds appropriated in this
16 Ordinance shall not lapse but shall carryover to fiscal year 2024-
17 2025.

18 **Section 4. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
