7 AN ORDINANCE ESTABLISHING THE JACKSONVILLE
8 JOURNEY FORWARD, A PUBLIC BODY OF THE CITY OF
9 JACKSONVILLE, WHICH SHALL EXIST AS A BOARD
10 WITHIN THE EXECUTIVE BRANCH OF THE CONSOLIDATED
11 GOVERNMENT, WITH THE COMPREHENSIVE MISSION OF
12 REDUCING FACTORS CONTRIBUTING TO CRIME IN DUVAL
13 COUNTY AND MAKING DUVAL COUNTY A SAFER AND MORE
14 PRODUCTIVE COMMUNITY BY ALIGNING ALL CITY
15 AGENCIES, PROGRAMS, AND RESOURCES AFFECTING
16 CRIME REDUCTION AND FOSTERING AN INTEGRATIVE,
17 COLLABORATIVE, AND INNOVATIVE COMMUNITY AND
18 COUNTY-WIDE, SOLUTION-BASED APPROACH TO CRIME
19 REDUCTION; CREATING A NEW CHAPTER 85
20 (JACKSONVILLE JOURNEY FORWARD), *ORDINANCE CODE*;
21 AMENDING SECTION 24.601 (ESTABLISHMENT;
22 FUNCTIONS), PART 6 (GRANTS AND CONTRACT

23 AMENDMENTS AND NEW PROVISIONS CONTAINED IN THIS
24 ORDINANCE TO BECOME EFFECTIVE; PROVIDING FOR
25 CODIFICATION; PROVIDING AN EFFECTIVE DATE.

26
27 **WHEREAS**, Article 3 of the Charter of the City of Jacksonville
28 (hereinafter "Charter") requires the City to be responsible for good
29 government and the health, safety, and welfare of the people; and

30 **WHEREAS**, in 2009, the Jacksonville Journey was established
31 under Mayor John Peyton to address the unacceptable number of violent

1 crimes, and through the Jacksonville Journey the City convened its
2 leaders and community stakeholders, public and private, to
3 collaborate and work together to find solutions and invest increased
4 human resources and money to identify and address factors that
5 contribute to crime; and

6 **WHEREAS,** following the implementation of the Jacksonville
7 Journey and substantial funding of crime reduction programs and
8 accountability for administering those programs, there was a
9 significant reduction in the violent crime rate from 2011 until
10 funding for Jacksonville Journey programs was reduced or eliminated
11 and administrative budget cuts caused elimination of 147 police
12 officer positions and 92 community service officer positions from the
13 Jacksonville Sheriff's Office; and

14 **WHEREAS,** police authorities, including prior sheriffs of
15 Duval County, have expressed that enforcement joined with City and
16 community stakeholder support is the best way to reach our shared
17 goal of ensuring the highest level of safety possible; and

18 **WHEREAS,** the Mayor desires to undertake executive actions and
19 create necessary entities to identify, reduce and eliminate factors
20 contributing to crime; coordinate with and support the Sheriff of
21 Duval County to assure the continued reduction of violent crime;
22 build on recent successes to assure Jacksonville is a safe and healthy
23 place to live and work; and erase the negative perception of
24 Jacksonville's crime rate; and

25 **WHEREAS,** the City is committed to taking all necessary steps
26 to reduce the contributing factors that lead to violent crime in the
27 City, reestablish the Jacksonville Journey as "Jacksonville Journey
28 Forward," reconvene community leaders and stakeholders to address
29 those factors and circumstances that contribute to crime, use the
30 collective power of the community to eliminate or reduce those factors
31 contributing to crime, and sustain the commitment to all Jacksonville

1 residents, neighborhoods and businesses that the City of Jacksonville
2 is a safe place to live and work without fear of violent crime; now
3 therefore

4 **BE IT ORDAINED** by the Council of the City of Jacksonville:

5 **Section 1. Recitals.** The recitals above are true and
6 correct and incorporated herein by reference.

7 **Section 2. Creating a new Chapter 85 (Jacksonville Journey**
8 **Forward), Ordinance Code.** A new Chapter 85 (Jacksonville Journey
9 Forward), *Ordinance Code*, is hereby created to read as follows:

10 **CHAPTER 85 - JACKSONVILLE JOURNEY FORWARD**

11 **Sec. 85.101. - Legislative intent.**

12 It is the intent of the Council to establish a public body of the
13 City, which shall exist as a board within the executive branch of
14 the consolidated government, with the comprehensive mission of
15 reducing the social factors that contribute to crime in Duval County
16 and making Duval County a safer and more productive community by
17 aligning all City agencies, programs, and resources affecting crime
18 reduction and fostering an integrative, collaborative, and
19 innovative county and community-wide solution-based approach to
20 reducing crime. In executing its mission, this community-based board
21 shall work in collaboration with the Jacksonville Sheriff's Office
22 but without exercising oversight, governance, or control of its
23 operations and initiatives.

24 **Sec. 85.102. - Legislative findings and declaration.**

25 The Council finds and declares that:

- 26 (1) Violent crimes, juvenile delinquency, gang affiliation and
27 family disruption continue to impact the City to the City's
28 moral, economic, social, and academic detriment; and
29 (2) In 2009, the Jacksonville Journey was established to address the
30 unacceptable number of violent crimes and high crime rate in
31 Duval County and find solutions and invest increased resources

- 1 to identify and address factors that contribute to crime; and
- 2 (3) Following the implementation of the Jacksonville Journey and
- 3 substantial funding of crime reduction programs, accountability
- 4 for administration of those programs, and implementation of
- 5 intelligence-led and community-based policing, the City of
- 6 Jacksonville brought homicide and overall violent crime in
- 7 Jacksonville to a 40-year low in 2011 until funding for the
- 8 Jacksonville Journey was reduced substantially and
- 9 administrative budget cuts caused elimination of 147 police
- 10 officer positions and 92 community service officer positions
- 11 from the Jacksonville Sheriff's Office; and
- 12 (4) Recently, due to the efforts of the Sheriff of Duval County, the
- 13 violent crime rate has decreased and the City of Jacksonville
- 14 is committed to working with the Sheriff to assure the
- 15 improvement in public safety continues and all necessary steps
- 16 are taken to resolve and eliminate the factors contributing to
- 17 violent crime in the City; and
- 18 (5) The City of Jacksonville should reestablish the Jacksonville
- 19 Journey as the "Jacksonville Journey Forward," reconvene
- 20 community stakeholders and leaders to address those factors and
- 21 circumstances that contribute to crime, use the collective power
- 22 of the community to resolve those factors contributing to crime,
- 23 and sustain a commitment to assure all Jacksonville residents,
- 24 neighborhoods and businesses that the City will provide a safe
- 25 place to live and work; and
- 26 (6) The provisions of this Section are found and declared by the
- 27 Council to be a public purpose and in the best interest of the
- 28 public.

29 **Sec. 85.103. - Jacksonville Journey Forward established.**

30 There is hereby established a public body to be known as the

31 Jacksonville Journey Forward, which shall exist as a board within the

1 executive branch of the consolidated government. The Jacksonville
2 Journey Forward ("JF" or "Jacksonville Forward") shall be responsible
3 for reviewing and making recommendations regarding community-based
4 programs, services, activities, and contracts related to factors
5 contributing to crime prevention, intervention, and rehabilitation,
6 neighborhood safety and stability, and prevention of juvenile and
7 adult recidivism ("JF Related Programs"). JF shall also serve as a
8 convenor to organize and engage City agencies, offices, departments,
9 independent agencies, and community leaders and stakeholders to
10 establish a community-based Citywide plan and alignment of all
11 resources to reduce factors contributing to crime and improve public
12 safety. JF is authorized to preserve and register its name and
13 taglines on behalf of the City as to any logos, trademarks,
14 copyrights, or other intellectual property rights.

15 **Sec. 85.104. - Territorial jurisdiction.**

16 The Jacksonville Journey Forward may review and make recommendations
17 regarding JF Related Programs throughout the General Services
18 District. The City is exercising its powers as a County in the
19 enactment of this Chapter under the authority contained in Section
20 3.01 of the Charter.

21 **Sec. 85.105. - Membership, organization, and meetings.**

22 (a) *Membership; qualifications.* The Jacksonville Journey Forward
23 Board shall consist of eleven members of which four members
24 shall be appointed by the Mayor and confirmed by Council, three
25 members shall be appointed by the Council President and
26 confirmed by Council, and each of the following persons shall
27 make an appointment of one member to be confirmed by Council,
28 to wit: the Sheriff of Duval County, the State Attorney of the
29 Fourth Judicial Circuit, the Superintendent of Duval County
30 Public Schools, and the Chief Judge for the Fourth Judicial
31 Circuit. Members shall be permanent residents of Duval County

1 or maintain a substantial economic or substantial philanthropic
2 interest in Duval County in accordance with Chapter 50 of the
3 Code. To the extent feasible and preferred, but not required,
4 member appointments to serve on the JF board shall include
5 individuals with experience in one or more of the following
6 areas: public health, education, workforce development,
7 contract and compliance, afterschool/camp operations, juvenile
8 diversion programs, violence prevention or intervention, ex-
9 offender re-entry programs, law enforcement and community
10 engagement.

11 (b) *Term of office and appointment.* Members shall serve staggered
12 four-year terms ending on September 30 or until their qualified
13 successors have been appointed and confirmed. No member may
14 serve more than two consecutive full terms. Of the eleven persons
15 selected to initially serve on the Board, three members shall
16 serve initial terms of two years, four members shall serve
17 initial terms of three years, and four members shall serve
18 initial terms of four years. Partial terms shall be governed in
19 accordance with Chapter 50 of the Code.

20 (c) *Removal.* Members may be removed or replaced at any time, with
21 or without cause, by the authority appointing the respective
22 member with a majority vote of the Council.

23 (d) *Vacancy.* If a member shall cease to be qualified for membership
24 under the provisions of this Chapter while in office, then the
25 member's term shall automatically expire and the office shall
26 be vacant for purposes of appointing a new member. Each member
27 vacancy shall be filled for the remainder of the respective
28 member's unexpired term.

29 (e) *Organization and proceedings.*

30 (1) *Rules of procedure.* The Mayor shall appoint the initial Board
31 chair from among JF members to serve for a term commencing on

1 the day of the appointment and ending on June 30, 2026.
2 Thereafter, the chair shall be appointed by a majority vote
3 of the Board to serve for a one-year term, commencing on July
4 1 of each year. A board member may serve as chair for no more
5 than three consecutive terms. The Board shall establish rules
6 of procedure necessary to govern and conduct its affairs under
7 this Chapter. Unless otherwise provided in this Chapter, the
8 Board's rules and procedures shall be consistent with
9 applicable provisions of the Ordinance Code.

10 (2) *Meetings.* All Board meetings, including, but not limited to,
11 committee meetings, shall be open to the public and compliant
12 with Florida's Open Meetings Law under Chapter 286, Florida
13 Statutes, as may be amended.

14 (3) *Administrative Support.* The Jacksonville Journey Forward
15 Board shall receive staff support from the Mayor's Office.

16 (f) *Quorum and voting.*

17 (1) *Quorum.* The greater of (i) five members or (ii) a majority
18 of the membership of the board excluding vacant seats shall
19 constitute a quorum for the purpose of meetings and
20 transacting business.

21 (2) *Voting.* Decisions and recommendations of the board shall
22 require a concurring vote of a majority of the members
23 present.

24 (g) *Notice.* The Board shall ensure that reasonable notice of Board
25 meetings is given to the public in compliance with Florida's
26 Open Meetings Law under Chapter 286, Florida Statutes, as may
27 be amended.

28 (h) *Compensation.* Members shall serve without compensation, pension,
29 or retirement benefits; however, members may be reimbursed for
30 travel and other expenses consistent with Chapter 106, Part 7,
31 *Ordinance Code.*

- 1 (i) *Sheriff Liaison*. The Sheriff shall designate a liaison from the
2 Jacksonville Sheriff's Office to attend Board meetings ("Sheriff
3 Liaison"). The Sheriff Liaison shall not be considered a voting
4 member of the Board for purposes of Florida's Open Meetings Law.
- 5 (j) *Council Liaison*. The Council President shall annually designate
6 a City Council Member to serve as a liaison to the Jacksonville
7 Journey Forward Board. The Council Liaison shall not be
8 considered a voting member of the Board for purposes of Florida's
9 Open Meetings Law.

10 **Sec. 85.106. - Community Based Crime Reduction and Stakeholder**
11 **Meeting; Community Based Strategic Plan required.**

- 12 (a) *Community Based Crime Reduction and Stakeholder Meeting*. The
13 Board shall convene and engage community leaders and
14 stakeholders, including, but not limited to elected and
15 appointed officials, City agencies, offices, departments,
16 independent agencies, private agencies, public agencies,
17 residents, and non-profit agencies to assist the Board with
18 developing and implementing a community-based plan to reduce and
19 eliminate factors contributing to crime for the City (the
20 "Community-based Plan" or "Plan").
- 21 (b) *Plan components*. After convening and engaging community leaders
22 and stakeholders in accordance with subsection (a) above, the
23 Board shall develop and implement the Plan, which shall include
24 immediate and long-term actions and goals related to crime
25 reduction and public safety. The Plan shall identify its
26 specific community engagement process and program performance
27 metrics. The Plan shall at a minimum include information,
28 directives, and goals regarding the following areas:
- 29 i. Community-based crime prevention, intervention,
30 deterrence, and rehabilitation;
 - 31 ii. Family resources and engagement;

- 1 iii. Ex-offender programs;
- 2 iv. Neighborhood safety and stability;
- 3 v. Public and private community partnerships;
- 4 vi. Program performance metrics (short and long-term);
- 5 vii. Use of best practices and models; and
- 6 viii. Contributing factors of crime (e.g., education, mental
7 health, literacy, physical health, workforce training, and
8 positive youth development).

9 The Plan shall also include strategic efforts to unite and mobilize
10 the City to reduce factors contributing to crime and improve
11 safety of all citizens; establish roles, responsibilities and
12 expected outcomes; measure and oversee accountability to meet
13 expected outcomes; modify actions and goals as necessary to achieve
14 maximum effectiveness; and maintain a sustained focus to
15 maximize results.

16 (c) *Plan development and approval.* JF shall develop, oversee,
17 manage, and implement the Plan consistent with this Chapter. JF
18 shall develop the Plan in conjunction with and utilizing the
19 multidisciplinary experts available in the City and elsewhere.
20 The Plan shall be approved and adopted by the Board and,
21 thereafter, updated and amended by the Board as needed. The Plan
22 shall detail the comprehensive approach to community-based crime
23 prevention, intervention, and rehabilitation, and neighborhood
24 safety and stability. The Board shall provide the Mayor, Council
25 Secretary and the agencies listed in Section 85.111 with a copy
26 of the adopted Plan. In addition to the Plan areas listed in
27 subsections (i)-(viii) above, the Board may include such other
28 elements, directives, or guiding principles in the Plan as
29 determined by the Board to be necessary and consistent with this
30 Chapter.

31 (d) *Reports.*

1 (i) *Report on community initiatives.* The Board may request
2 philanthropic and research organizations to report on
3 recently commissioned research and trends they have
4 identified and outcomes they are monitoring regarding factors
5 contributing to crime prevention, intervention,
6 rehabilitation, and neighborhood safety and stability.

7 (ii) *Report Requirement.* JF shall provide to the Mayor and Council
8 an initial annual written report on or before December 31,
9 2025, for the prior fiscal year. Thereafter, JF shall provide
10 an annual report on or before December 31st of each fiscal
11 year for the prior fiscal year. The annual report shall at
12 a minimum report on JF's progress toward meeting its goals
13 and include financial information on the funding
14 appropriated and spent for each funded program. JF shall
15 utilize technology to provide transparent reporting to
16 include programs funding and stakeholder feedback. The
17 annual report shall also be distributed to the agencies
18 listed in Section 85.111.

19 (e) *Plan review; amendment.* JF shall conduct an ongoing and
20 continuing review of the Plan's progress and effectiveness. JF
21 may amend the Plan by a majority vote of the Board. Plan
22 amendments shall be forwarded to the Mayor, Council Secretary
23 and agencies listed in Section 85.111.

24 **Sec. 85.107. - Jacksonville Journey Forward Powers.**

25 (a) *Powers.* JF shall have the following powers to:

- 26 i. Develop, manage, oversee, and implement the Community-
27 Based Strategic Plan in accordance with this Chapter;
- 28 ii. Investigate the efficacy of City and community crime
29 reduction or public safety programs and conduct ongoing
30 review and make recommendations regarding such programs;
- 31 iii. Align all City agencies, programs, and resources affecting

1 crime reduction and foster an integrative, collaborative,
2 and innovative county and community-wide, solution-based
3 approach to reducing contributing factors of crime in Duval
4 County;

5 iv. Analyze feedback received from community leaders and
6 stakeholders and data received from City contracts that
7 involve or pertain to contributing factors of crime
8 reduction;

9 v. Based on data analysis and other factors determined by JF
10 and consistent with the Community-Based Plan, make annual
11 recommendations on programs to be funded by the City
12 Council in the annual budget, subject to the availability
13 of funds;

14 vi. Advocate for the investment of new public and private
15 dollars as well as state and federal policy initiatives
16 consistent with the Plan;

17 vii. Collect ongoing information and statistical data and
18 conduct ongoing research on community-based crime
19 prevention, intervention, deterrence, and,
20 rehabilitation;

21 viii. Review and make recommendations regarding the City's ex-
22 offender programs and the Ex-Offender Program in Part 5 of
23 Chapter 126 of the Code;

24 ix. Review and make recommendations to the Sheriff regarding
25 the Jacksonville Re-Entry Center program;

26 x. Coordinate with the Division of Grants and Contract
27 Compliance or other appropriate City departments for
28 federal, state, local, and privately funded grants to
29 obtain funding for programs and services that are
30 consistent with the Plan;

31 xi. Request funds to be disbursed from the special revenue

- 1 fund in accordance with Section 111.330 of the Code;
- 2 xii. Employ employees of the Board pursuant to this Chapter;
- 3 and
- 4 xiii. Make and adopt bylaws, rules, regulations and policies for
- 5 the Board's guidance, operation, and governance; however,
- 6 the Board's bylaws, rules, regulations and policies shall
- 7 not be inconsistent with this Chapter, federal or state
- 8 laws or other applicable City ordinances.

9 **Sec. 85.108. - Employees; Civil Service.**

- 10 (a) The Board may, subject to lawfully appropriated funds, employ
- 11 such persons as may be necessary to effectively conduct and
- 12 accomplish the affairs and duties of the Board under this
- 13 Chapter. All employment matters shall be handled with assistance
- 14 from the City's Employee Services Department and be consistent
- 15 with the City's human resource policies and requirements.
- 16 (b) *Civil service.* All employees of the Board shall be employees of
- 17 the City and shall be subject to Articles 16 and 17 of the
- 18 Charter of the City, except as otherwise provided by Council,
- 19 and except that any Chief Executive Officer or Executive
- 20 Director, professional employees, and the heads of activities
- 21 shall not be within the civil service system of the City and
- 22 shall serve at the pleasure of the Board. Appointment of a Chief
- 23 Executive Officer or Executive Director shall be subject to
- 24 confirmation by the Council.

25 **Sec. 85.109. - Annual operating budget; budget transfers.**

26 JF shall annually submit a proposed budget to the Mayor at the time

27 and in the manner specified by the Mayor. The Mayor shall include an

28 annual budget for JF in the Mayor's annual budget proposal.

29 **Sec. 85.110. - Coordination with other public and private agencies;**

30 **Use of subject matter experts.**

31 JF shall coordinate with federal, state, and private agencies in

1 performing its duties. Such agencies may include, but not be limited
2 to, the Florida Department of Juvenile Justice, the Sheriff's Office,
3 the State Attorney's Office, the Public Defender's Office, Duval
4 County Public Schools, Kids Hope Alliance, Jacksonville Civic
5 Council, and the Jacksonville Chamber of Commerce. The Board shall
6 designate individuals as subject matter experts ("Subject Matter
7 Experts") with expertise in public health, education, community-based
8 crime reduction and public safety. The Board may consult with and
9 receive presentations from Subject Matters Experts and residents to
10 assist with community convening, engagement, data collection and
11 analysis for the purpose of developing program metrics and support
12 the Board in fulfilling its duties under this Chapter. Subject Matter
13 Experts and citizen participants shall not be considered Board members
14 for purposes of Florida's Open Meetings Law.

15 **Sec. 85.111. - Intra-agency liaison relationships established.**

16 JF shall coordinate regularly with City departments, agencies, and
17 offices in developing and implementing the Plan. The Board shall
18 establish a liaison relationship with the following City departments,
19 independent agencies, and offices regarding the Services to be
20 provided under the Plan:

- 21 (a) Jacksonville Sheriff's Office;
- 22 (b) Kids Hope Alliance;
- 23 (c) Parks, Recreation and Community Services Department;
- 24 (d) Jacksonville Public Library;
- 25 (e) Neighborhoods Department;
- 26 (f) Grants and Contract Compliance Division;
- 27 (g) Duval County School Board;
- 28 (h) Jacksonville Housing Authority;
- 29 (i) Jacksonville Housing Finance Authority; and
- 30 (j) Any other City departments, offices or independent agencies as
31 determined by the Board.

1 A designated liaison from a City department or independent agency
2 shall not be a JF Board member. The liaison's sole purpose shall be
3 to facilitate and communicate information between the JF Board and
4 the City department or agency. The Board shall annually present to
5 the Rules Committee on the effectiveness of the intra-agency liaison
6 relationships required under this Section within three months of the
7 close of the fiscal year, with the first report due before December
8 31, 2025.

9 **Sec. 85.112. - Advisory committees.**

10 The Board may by rule create one or more advisory committees
11 consisting of representatives of groups, organizations, businesses,
12 and persons involved in community-based crime reduction efforts. An
13 advisory committee may be permanent or ad hoc and its area of
14 responsibility shall be established, expanded, contracted, or
15 changed by the Board as it deems necessary and advisable.

16 **Sec. 85.113. - Special Revenue Fund.**

17 JF is authorized to expend funds in the Special Revenue Fund
