7 **ORDINANCE 2024-807-E**

8 AN ORDINANCE DISSOLVING THE HOGPEN DEPENDENT
9 SPECIAL DISTRICT PER CHAPTER 189, FLORIDA
10 STATUTES; DIRECTING THE CHIEF OF THE LEGISLATIVE
11 SERVICES DIVISION TO FORWARD A COPY OF THIS
12 ORDINANCE, WITHIN THIRTY DAYS OF ITS ENACTMENT,
13 TO THE FLORIDA DEPARTMENT OF COMMERCE SPECIAL
14 DISTRICT ACCOUNTABILITY PROGRAM, THE DUVAL
15 COUNTY TAX COLLECTOR'S OFFICE, AND THE HOGPEN
16 DEPENDENT SPECIAL DISTRICT; PROVIDING AN
17 EFFECTIVE DATE.

19 **WHEREAS**, the City of Jacksonville established the Hogpen
20 Dependent District per Ordinance 2023-146-E; and

21 **WHEREAS**, per Section 189.071, *Florida Statutes*, the City
22 Council may enact an ordinance dissolving a dependent special
23 district; and

24 **WHEREAS**, it is the intent of the City Council to dissolve the
25 Hogpen Dependent Special District, in accordance with the
26 requirements set forth in Chapter 189, *Florida Statutes*; now
27 therefore

28 **BE IT ORDAINED** by the Council of the City of Jacksonville:

29 **Section 1. Dissolution.** The Hogpen Dependent Special
30 District is hereby dissolved, consistent with the provisions set
31 forth in Chapter 189, *Florida Statutes*. As part of the dissolution,

1 the Hogpen Dependent Special District (the "District") shall resolve
2 any debts of the District consistent with Section 189.062, *Florida*
3 *Statutes*, and shall refund any remaining unspent and unobligated
4 moneys collected as assessments by the District consistent with
5 Section 189.021, *Florida Statutes*.

6 **Section 2. Directive to Chief of Legislative Services**
7 **Division.** The Chief of the Legislative Services Division is hereby
8 directed to provide a copy of this legislation, within thirty days
9 of its enactment, to the Florida Department of Commerce Special
10 District Accountability Program, the Duval County Tax Collector's
11 Office, and the Hogpen Dependent Special District.

12 **Section 3. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
