4 **ORDINANCE 2024-845-E**

5 AN ORDINANCE AMENDING SECTION 380.108 (OPERATION
6 OF SOLID WASTE DISPOSAL OR MANAGEMENT FACILITY),
7 PART 1 (CERTIFICATE OF PUBLIC CONVENIENCE AND
8 NECESSITY), CHAPTER 380 (SOLID WASTE
9 MANAGEMENT), *ORDINANCE CODE*, TO ADDRESS TYPES OF
10 WASTE THAT MAY BE ACCEPTED AT A SOLID WASTE
11 TRANSFER STATION IN DUVAL COUNTY AND TO LIMIT
12 THE TYPES OF WASTE AUTHORIZED TO BE DISPOSED OF
13 IN THE DUVAL COUNTY TRAIL RIDGE LANDFILL;
14 PROVIDING FOR CODIFICATION INSTRUCTIONS;
15 PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Amending Section 380.108 (Operation of solid**
19 **waste disposal or management facility), Part 1 (Certificate of Public**
20 **Convenience and Necessity), Chapter 380 (Solid Waste Management),**
21 ***Ordinance Code*.** Section 380.108 (Operation of solid waste disposal
22 or management facility), Part 1 (Certificate of Public Convenience
23 and Necessity), Chapter 380 (Solid Waste Management), *Ordinance Code*,
24 is hereby amended to read as follows:

25 **CHAPTER 380 - SOLID WASTE MANAGEMENT**

26 **PART 1. - CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY**

28 **Sec. 380.108. - Operation of solid waste disposal or management**
29 **facility.**

30 The following regulations apply to the operation of a solid waste
31 disposal or management facility:

2 (q) Transfer stations operating in Duval County which shall only
3 accept waste that is required to be disposed of in a Class I
4 facility shall only accept waste of those types that has been
5 generated in Duval County.~~or any solid waste or recoverable~~
6 ~~materials collected by municipally-contracted haulers as part~~
7 ~~of municipal collection services within Duval County.~~ Waste
8 that has been generated inside or outside of Duval County
9 that is not required to be disposed of in a Class I facility
10 is not restricted from delivery to a transfer station facility
11 located in Duval County if: (1) the waste is not commingled
12 with waste that is required to be disposed of in a Class I
13 facility, and (2) the transfer station facility is properly
14 permitted to receive the types of waste not required to be
15 disposed of in a Class I facility. Waste generated outside of
16 Duval County and received at a transfer station facility
17 located in Duval County which has not been commingled with
18 waste required to be disposed of in a Class I facility shall
19 not be directed to a Class I disposal facility owned by the
20 City. Notwithstanding the above, any solid waste collected by
21 municipally-contracted haulers as part of municipal
22 collection services within Duval County shall not be
23 restricted from bringing wastes to a transfer station or be
24 limited to where this material is ultimately directed for
25 disposal or recycling so long as the municipal wastes are not
26 commingled with non-municipal wastes not required to be
27 disposed of in a Class I facility. Municipally-contracted
28 haulers for purposes herein are defined as the haulers
29 contracted by the Town of Baldwin, the City of Atlantic Beach,
30 the City of Jacksonville Beach, the City of Neptune Beach and
31 the City of Jacksonville for municipal collection services.

2 **Section 2. Codification Instructions.** The Codifier and the
3 Office of General Counsel are authorized to make all chapter and
4 division "tables of contents" consistent with the changes set forth
5 herein. Such editorial changes and any others necessary to make the
6 *Ordinance Code* consistent with the intent of this legislation are
7 approved and directed herein, and changes to the *Ordinance Code* shall
8 be made forthwith and when inconsistencies are discovered.

9 **Section 3. Effective Date.** This Ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
