1 The funding above represents a transfer of 19,825,414.00
2 from General Fund Collective Bargaining Contingency,
3 reducing \$1,459,446 from the International Association of
4 Fire Fighters / Fraternal Order of Police Health Trust
5 account within the Group Health Fund and appropriating
6 \$54,285.00 from fund balance within the Building Inspection
7 Fund to cover the wage increase for International
8 Association of Fire Fighters (IAFF) union employees for
9 fiscal year 2024-2025.

10 **Section 2. Purpose.** The purpose of the appropriation in
11 Section 1 is to provide funding to cover the various line items
12 outlined in B.T. 25-009 relative to the general wage increase for
13 IAFF union employees effective on October 1, 2024.

14 **Section 3. Effective Date.** This Ordinance shall become
15 effective upon signature by the Mayor or upon becoming effective
16 without the Mayor's signature.
