4 **ORDINANCE 2019-435**

5 AN ORDINANCE APPROPRIATING \$71,874.00 FROM THE
6 KIDS HOPE ALLIANCE OPERATING SUBFUND INTO THE
7 KIDS HOPE ALLIANCE BUDGET TO FUND AFTERSCHOOL
8 PROGRAMMING; AUTHORIZING THE KIDS HOPE
9 ALLIANCE TO CONTRACT DIRECTLY WITH THE YMCA OF
10 FLORIDA'S FIRST COAST, INC. ("YMCA") TO
11 PROVIDE AFTERSCHOOL PROGRAMMING AT WINDY HILL,
12 RAMONA AND JACKSONVILLE HEIGHTS ELEMENTARY
13 SCHOOLS; INVOKING THE EXCEPTION OF SECTION
14 126.107(G) (EXEMPTIONS), PART 1 (GENERAL
15 REGULATIONS), CHAPTER 126 (PROCUREMENT CODE),
16 *ORDINANCE CODE*, TO ALLOW THE KIDS HOPE
17 ALLIANCE TO PROCURE AFTERSCHOOL PROGRAMMING
18 FROM YMCA; AUTHORIZING THE MAYOR, OR HIS
19 DESIGNEE, AND CORPORATION SECRETARY, AND/OR
20 THE CHIEF EXECUTIVE OFFICER OF THE KIDS HOPE
21 ALLIANCE TO EXECUTE AND DELIVER A CHILDREN'S
22 SERVICES CONTRACT WITH YMCA; WAIVING THE
23 REQUIREMENTS OF SECTION 77.111(a) (PROVIDER
24 CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE),
25 *ORDINANCE CODE*, TO EXEMPT CHILDREN'S SERVICES
26 PROGRAMMING TO BE PROVIDED BY YMCA FROM
27 COMPETITIVE PROCUREMENT; PROVIDING AN
28 EFFECTIVE DATE.

30 **BE IT ORDAINED** by the Council of the City of Jacksonville:

31 **Section 1. Appropriation.** For the 2018-2019 fiscal year,

1 within the City's budget, there are hereby appropriated the
2 indicated sum(s) from the account(s) listed in subsection (a) to

9 The funding above is an appropriation of \$71,874 from the Kids Hope
10 Alliance operating subfund fund balance into the Kids Hope Alliance
11 operating budget.

12 **Section 2. Invoking the exception to Section 126.107(g)**
13 **(Exemptions), Part 1 (General Regulations), Chapter 126**
14 **(Procurement Code), Ordinance Code.** As shown on the Eighth Revised
15 2018-504-E Schedule M, a copy of which is attached hereto as
16 **Exhibit 2**, the Kids Hope Alliance is hereby authorized to procure
17 afterschool children's services from YMCA at Windy Hill, Ramona,
18 and Jacksonville Heights Elementary Schools in the amount of
19 \$71,874.00. Pursuant to Section 126.107(g) (Exemptions), Part 1
20 (General Regulations), Chapter 126 (Procurement Code), *Ordinance*
21 *Code*, such services are exempted from competitive solicitation
22 because the children's services to be provided by YMCA are being
23 appropriated and approved in this authorizing legislation.

24 **Section 3. Approval and authorization to execute.** As
25 authorized in Section 1 above, the Mayor, or his designee, the
26 Corporation Secretary, and/or the Chief Executive Officer of the
27 Kids Hope Alliance ("CEO") are hereby authorized to execute an
28 afterschool programming contract with YMCA. The afterschool
29 programming contract with YMCA shall be in the amount of \$71,874.00
30 and have a term from August 1, 2019 through September 30, 2019.
31 The contract with YMCA shall be subject to the terms and conditions
