Commencing at the intersection of the Southerly line of Beach Boulevard and the Easterly line of University Boulevard South; run thence South 4°50' West along the Easterly line of said University Boulevard South 960.19 feet to a point which is the point of beginning; from said point of beginning continue thence South 4°50' West 135.19 feet to an iron; run thence South 86°14'30" East 273.26 feet to an iron; run thence North 4°50' East 135.19 feet to a point; run thence North 86°14'30" West 273.26 feet to the point of beginning.

<u>Easement I:</u> An easement in common for vehicular parking over and upon land leased by lessors from University Hospital Building, Inc., described as:

East, more particularly described as follows: Commence at the intersection
of the North line of Harvin Road and the East line of University Boulevard
South, which is distant 40 feet East of and parallel to the center line of the
existing pavement of said University Boulevard South; thence North 4 degrees
50 minutes East and along said East line a distance of 1175.75 feet to an iron
for the point of beginning. From the point of beginning thus described run
South 86 degrees 14 minutes 30 seconds East a distance of 210.00 feet to an
iron; thence South 4 degrees 49 minutes West a distance of 92.62 feet to a
nail; thence North 86 degrees 10 minutes West a distance of 210.00 feet to the
iron; thence North 4 degrees 50 minutes East 88.69 feet along the East line of
University Boulevard South to the point of beginning. According to survey made
by Ellis, Curtis & Kooker, Civil Engineers & Surveyors, on March 11, 1969.

Easement II:

An easement in common 5 feet in width (measured North to South) running East and West along the Northerly boundary of the property of University Hospital Building, Inc., as described in dead recorded in Official Records Book 2497, page 63, public records of Duval County, Plorids, between the easterly line of the property described in Parcel 1 above and the walkway connecting the Long Term Care Facility and the main Hospital building on the property described in said deed; said easement shall be used for a walkway;

<u>Casement III:</u>

An easement in common for ingress and egress over and upon a strip of land 20 feet in width lying along the Wasterly boundary lind of the property of University Hospital Building, Inc., described in deed recorded in Official Records Book 2872, page 378, of saic County records, on which the Long Term Care Facility is being constructed. Said easement to extend from the 22 foot road for ingress and egress to be constructed by Lessors between University Boulevard South and Hickman Road to the Northerly side of the walkway easement described in Easement II above.

Richard Mill Grant, Section 52, Township 2 South, Range 27 East, Duval County, Florida, more particularly described as follows: Commencing at the intersection of the Southerly line of Beach Boulevard and the Easterly line of University Boulevard South; thence South 4 50' West, along the Easterly line of said University Boulevard South 965.72 feet; thence South 86 10' East; 105.7 feet; thence South 4 50' West, 14.0 feet; thence North 86 10' West, 4.7 feet; thence South 4 50' West, 5.72 feet to the Point of Beginning; thence continue South 4 50' West, 23.90 feet; thence South 86 10' East, 6.15 feet; thence North 4 50' East, 4.35 feet; thence South 86 10' East, 5.6 feet; thence North 4 10' East, 10.0 feet; thence North 86 10' West, 7.25 feet; thence North 4 50' East, 9.55 feet; thence North 86 10' West, 4.55 feet to the Point of Beginning, containing 182.425 square feet.
