5 AN ORDINANCE APPROPRIATING \$761,021.04 FROM  
6 THE CHILD SUPPORT ENFORCEMENT DIVISION OF THE  
7 FLORIDA DEPARTMENT OF REVENUE ("DOR") TO  
8 PROVIDE FUNDING TO THE JACKSONVILLE SHERIFF'S  
9 OFFICE FOR THE SERVICE OF PROCESS BY THE CIVIL  
10 PROCESS UNIT OF THE JACKSONVILLE SHERIFF'S  
11 OFFICE (JSO) FOR CHILD SUPPORT CASES FOR THE  
12 STATE OF FLORIDA DEPARTMENT OF REVENUE - CHILD  
13 SUPPORT STANDARD CONTRACT BETWEEN THE DUVAL  
14 COUNTY SHERIFF'S OFFICE AND THE FLORIDA  
15 DEPARTMENT OF REVENUE ("DOR") FOR THE SERVICE  
16 OF PROCESS IN THE DOR CHILD SUPPORT  
17 ENFORCEMENT PROGRAM, AS INITIATED BY B.T. 19-  
18 103; APPROVING AND AUTHORIZING THE MAYOR, OR  
19 HIS DESIGNEE, AND CORPORATION SECRETARY TO (1)  
20 EXECUTE AND DELIVER THE STATE OF FLORIDA  
21 DEPARTMENT OF REVENUE - CHILD SUPPORT STANDARD  
22 CONTRACT BETWEEN THE DUVAL COUNTY SHERIFF'S  
23 OFFICE AND THE FLORIDA DEPARTMENT OF REVENUE  
24 ("DOR") FOR THE SERVICE OF PROCESS IN THE DOR  
25 CHILD SUPPORT ENFORCEMENT PROGRAM AND OTHER  
26 DOCUMENTS NECESSARY OR APPROPRIATE TO  
27 EFFECTUATE THE PURPOSE OF THIS ORDINANCE AND  
28 (2) TAKE, OR CAUSE TO BE TAKEN, FOR AND ON  
29 BEHALF OF THE CITY, SUCH FURTHER ACTION TO  
30 EFFECTUATE THE PURPOSE OF THIS ORDINANCE;  
31 PROVIDING AN EFFECTIVE DATE.

2 **BE IT ORDAINED** by the Council of the City of Jacksonville:

3 **Section 1. Appropriation.** For the 2018-2019 fiscal year,  
4 within the City's budget, there are hereby appropriated the  
5 indicated sum(s) from the account(s) listed in subsection (a) to  
6 the accounts(s) listed in subsection (b):

13 (c) Explanation of Appropriation

14 The funding above is from the State of Florida, Child  
15 Support Enforcement Division for the service of process  
16 by the Civil Process Unit of the Jacksonville Sheriff's  
17 Office (JSO) for child support cases.

18 **Section 2. Purpose.** The purpose of the appropriation in  
19 Section 1 is to provide funding from the State of Florida Child  
20 Support Enforcement Division to JSO to offset the salary expenses  
21 of both part-time and full-time authorized employees in the Civil  
22 Process Unit for the period July 1, 2019, through June 30, 2024.

23 **Section 3. Authorization.** There is hereby approved, and  
24 the Mayor, or his designee, and Corporation Secretary are hereby  
25 authorized to (i) execute and deliver, for and on behalf of the  
26 City, the State of Florida Department of Revenue - Child Support  
27 Standard Contract between the Duval County Sheriff's Office and the  
28 Florida Department of Revenue ("DOR") for the service of process in  
29 the DOR Child Support Enforcement Program, in substantially the  
30 same form placed **ON FILE** with the Office of Legislative Services,  
31 and other documents necessary or appropriate to effectuate the

1 purpose of this ordinance and (ii) take, or cause to be taken, for  
2 and on behalf of the City, such further action to effectuate the  
3 purpose of this ordinance.

4 **Section 4. Effective Date.** This ordinance shall become  
5 effective upon signature by the Mayor or upon becoming effective  
6 without the Mayor's signature.
