ORDINANCE AUTHORIZING AND DIRECTING ΑN MAYOR AND CORPORATION SECRETARY TO EXECUTE AN ADDITIONAL MODIFICATION TΟ ΑN AGREEMENT AMENDING THE SETTLEMENT AGREEMENT DATED MARCH 1994, AMONG B&B ADVERTISING CITY CAPSIGNS AND THE OF PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Jacksonville, Capsigns, Inc., and B&B Advertising Company entered into a settlement agreement dated March 1, 1994 (the "1994 Agreement"), resolving litigation concerning the City's billboard regulations; and

WHEREAS, on July 14, 2000, the City of Jacksonville, Scenic Jacksonville, Inc. d/b/a Capsigns, Inc., and Wesley A. Miner, owner of B&B Advertising Company, Inc., agreed to certain modifications to the 1994 Agreement resulting in more billboards being removed than was required under the 1994 Agreement; and

WHEREAS, the City of Jacksonville, Scenic Jacksonville, Inc. d/b/a Capsigns, Inc., and Wesley A. Miner, owner of B&B Advertising Company, Inc., have agreed to an additional modification to the 1994 Agreement that, among other things, will result in more billboards being removed than was required under the 1994 Agreement; and

WHEREAS, the City Council finds it to be in the best interest of the City to agree to the terms in the proposed Additional Modification to Agreement; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Approval of Modification. The proposed Additional Modification to Agreement (attached to which are the 1994 and 2000 Agreements), attached hereto as Exhibit 1, is hereby approved and the Mayor and Corporation Secretary are hereby authorized and directed to execute the Additional Modification to Agreement on behalf of the City.

Section 2. Effective Date. This ordinance shall become effective upon signature of the Mayor or upon becoming effective without the Mayor's signature.
