5 AN ORDINANCE APPROPRIATING \$543,289.35 IN
6 GRANT FUNDS FROM THE U. S. DEPARTMENT OF
7 JUSTICE, BUREAU OF JUSTICE ASSISTANCE, THROUGH
8 THE STATE ATTORNEY'S OFFICE, FOURTH JUDICIAL
9 CIRCUIT OF FLORIDA, UNDER THE FISCAL YEAR 2018
10 NATIONAL SEXUAL ASSAULT KIT INITIATIVE (SAKI),
11 WITH NO LOCAL MATCH, TO PROVIDE SALARIES AND
12 BENEFITS TO ONE FULL-TIME COLD CASE DETECTIVE
13 IN FISCAL YEAR 2020 AND FISCAL YEAR 2021 WHO
14 WILL WORK EXCLUSIVELY ON SAKI, INCLUDING
15 TRAVELING TO COLLECT LAWFULLY OWNED DNA
16 EVIDENCE, AND TO PROVIDE FUNDS FOR THE
17 PURCHASE OF ADDITIONAL SUPPLIES TO FACILITATE
18 THE COLLECTION AND TESTING OF DNA EVIDENCE, AS
19 INITIATED BY B.T. 20-007; APPROVING AND
20 AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND
21 THE CORPORATION SECRETARY TO EXECUTE AND
22 DELIVER, FOR AND ON BEHALF OF THE CITY, THE
23 SUBCONTRACT BETWEEN THE STATE ATTORNEY'S
24 OFFICE, 4TH JUDICIAL CIRCUIT, AND THE
25 JACKSONVILLE SHERIFF'S OFFICE (JSO); PROVIDING
26 FOR OVERSIGHT BY THE JSO DEPARTMENT OF
27 INVESTIGATIONS AND HOMELAND SECURITY;
28 APPROVING POSITION, AS INITIATED BY R.C. 20-
29 005; PROVIDING FOR AN EFFECTIVE DATE.

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1 Jacksonville Sheriff's Office (JSO), a copy of which has been
2 placed **ON FILE** with the Office of Legislative Services.

3 **Section 4. Oversight.** The JSO Department of
4 Investigations and Homeland Security shall oversee the project
5 described herein.

6 **Section 5. Approval of Position.** There is hereby
7 approved the position more fully described in R.C. 20-005, attached
8 hereto as **Exhibit 3** and incorporated herein by this reference.

9 **Section 6. Effective Date.** This ordinance shall become
10 effective upon signature by the Mayor or upon becoming effective
11 without the Mayor's signature.
