5 AN ORDINANCE APPROPRIATING \$50,000.00 FROM  
6 THE COUNTYWIDE ECONOMIC DEVELOPMENT-II PROJECT  
7 TO THE JACKSONVILLE FILM & TELEVISION JOB &  
8 BUSINESS CREATION INCENTIVE PROGRAM WITHIN THE  
9 PUBLIC INVESTMENT POLICY OF THE OFFICE OF  
10 ECONOMIC DEVELOPMENT, AS AMENDED BY ORDINANCE  
11 2019-243-E, AS INITIATED BY B.T. 19-108;  
12 PROVIDING FOR AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2018-2019 fiscal year,  
16 within the City's budget, there are hereby appropriated the  
17 indicated sum(s) from the account(s) listed in subsection (a) to  
18 the accounts listed in subsection (b):

26 Appropriating \$50,000 of available funds from the  
27 Countywide Economic Development-II Project to fund the  
28 Jacksonville Film & Television Job & Business Creation  
29 Incentive Program (the "Program").

30 **Section 2. Purpose.** The purpose of the appropriation in  
31 Section 1 is to provide funding to implement the Program, which

1 allows for a 10% rebate to eligible film and television production  
2 companies for qualified expenditures in Duval County. To be  
3 eligible for the 10% rebate authorized by the incentive, a company  
4 must have a minimum of \$50,000 of qualified expenditures, with a  
5 maximum reimbursement of up to \$50,000. The Program is a part of  
6 the Public Investment Policy of the Office of Economic Development,  
7 as amended by Ordinance 2019-243-E.

8 **Section 3. Effective Date.** This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
