6 A RESOLUTION OF COUNCIL SUPPORTING A
7 SUSPENSION OF ACTION ON LEGISLATION SEEKING TO
8 DONATE SURPLUS CITY VEHICLES UNTIL A POLICY IS
9 FINALIZED BY THE ADMINISTRATION; REQUESTING
10 EMERGENCY PASSAGE UPON INTRODUCTION; PROVIDING
11 FOR A PROSPECTIVE EFFECTIVE DATE; PROVIDING AN
12 EFFECTIVE DATE.

14 **WHEREAS**, it is the policy of the City to sell or otherwise
15 dispose of the City's tangible personal property for fair market
16 value unless the public interests supporting disposing of the such
17 property is for some other public purpose; and

18 **WHEREAS**, Section 122.812(c) of the *Ordinance Code* provides a
19 process by which tangible personal property can be conveyed or
20 donated for less than the fair market value by ordinance, provided
21 that certain safeguards enumerated in subsection (c) are met; and

22 **WHEREAS**, over the last several years the Council has approved
23 legislation conveying surplus vehicles, in particular, to non-for-
24 profit groups, the Duval County School Board and the town of
25 Baldwin; and

26 **WHEREAS**, the Administration has indicated that it is in the
27 process of finalizing a policy regarding the conveyance of surplus
28 vehicles; and

29 **WHEREAS**, the Council desires to be respectful of the
30 Administration and to allow it to develop a policy and further

1 desires to show its support of a policy by this resolution; and

2 **WHEREAS**, as a result the Council resolves that it will refrain
3 from acting on legislation which proposes to convey surplus
4 vehicles until the Administration has issued its policy on this
5 matter; and

6 **WHEREAS**, the Council believes that emergency action on this
7 resolution is necessary to convey its support for the issuance of a
8 policy by the Administration; now therefore

9 **BE IT RESOLVED** by the Council of the City of Jacksonville:

10 **Section 1. Support for Issuance of Policy and Resolve to**
11 **Refrain from Acting on Legislation Conveying Surplus Vehicles until**
12 **a Policy is in Place.** The Council of the City of Jacksonville
13 hereby offers its support of the issuance of a policy by the
14 Administration on the conveyance of surplus vehicles. The Council
15 resolves that it desires to refrain from taking action on
16 legislation conveying surplus vehicles until the Administration has
17 issued the policy.

18 **Section 2. Rule 4.901 Requesting Emergency Passage.**
19 Emergency passage of this legislation is requested upon
20 introduction. The nature of the emergency is that the
21 Administration is currently finalizing a policy on the conveyance
22 of surplus vehicles but legislation is pending and other
23 legislation may be filed to convey surplus vehicles before the
24 Administration has finalized the policy. The Council would like to
25 show its resolve to refrain on action on legislation moving
26 forward.

27 **Section 3. Prospective Effective Date.** This resolution
28 shall become effective August 22, 2019.

29 **Section 4. Effective Date.** This Resolution shall become
30 effective upon signature by the Mayor or upon becoming effective
31 without the Mayor's signature.
