AN ORDINANCE AUTHORIZING THE TRANSFER OF \$49,200 FROM THE COUNCIL OPERATING CONTINGENCY TO PAY FOR PROJECT COSTS FOR THE MIGRATION OF HISTORICAL DATA FROM EXISTING SYSTEMS TO THE GRANICUS PLATFORM; PROVIDING FOR A CARRYOVER OF FUNDS INTO THE 2019-2020 FISCAL YEAR; REQUESTING ONE-CYCLE EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2018-2019 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

The funding above is being appropriated from the Council Operating Contingency to hardware/software maintenance and licenses within City Council Staff Services for costs related to the purchase of data migration services for historical data currently housed in existing legacy

systems International Roll Call, Haivision and OnBase into the Granicus platform. The data to be migrated includes meeting videos, agendas, minutes, agenda items, agenda action history and attachments. Migrated information will subsequently be available and viewable on the City Council's public facing web portal.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to transfer funding to City Council for costs related to data migration of historical data currently housed in existing legacy systems International Roll Call, Haivision and OnBase into the Granicus platform. The data to be migrated includes meeting videos, agendas, minutes, agenda items, agenda action history and attachments. Migrated information will subsequently be available and viewable on the City Council's public facing web portal. The funding will also provide for continued maintenance, service, and support for the International Roll Call System until the migration is complete.

Section 3. Carryover. The funds appropriated in Section 1 of this ordinance shall not lapse but shall carryover into fiscal year 2019-2020.

Section 4. Requesting One Cycle Emergency Passage Pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that the data migration of existing legacy systems must be purchased imminently to maintain historical data.

Section 5. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
