(c) Explanation of Appropriation

The funding above in the amount of \$366,500.00 (an appropriation of \$296,778.23 from the Special Law Enforcement Trust Fund (the "Fund") and a deappropriation of \$69,721.77 from the Fund) is provided to establish the fiscal year 2019-2020 budget for the Fund, and to authorize intrafund transfers to the Teen Driver Special Revenue Fund and the Police Explorer Fund.

Section 2. Purpose. The purposes of the appropriation in Section 1 are to: i) provide funding in the amount of \$351,000.00 to establish the fiscal year 2019-2020 budget for the Special Law Enforcement Trust Fund (subfund 64A) pursuant to Section 111.310, Ordinance Code, specifically \$36,000.00 to reimburse the General for forfeiture-related expenditures Fund per Section 932.7055(4)(c), Florida Statute, \$10,000.00 to fund the Homeward Bound Program, \$80,000.00 to fund the expansion of the berm at the firing range, and \$225,000.00 to fund leasehold improvements for the new Zone 6 Substation; ii) authorize the transfer of \$3,000.00 to the Teen Driver Special Revenue Fund (subfund 64A) pursuant to Section 111.365, Ordinance Code; and, iii) authorize the transfer of \$12,500.00 to the Police Explorer Trust Fund (subfund 64C) pursuant to Section 111.340, Ordinance Code. A Certification that the request from the Special Law Enforcement Trust Fund complies with §932.7055, Florida Statutes, is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 3. Effective Date. This ordinance shall become
