AND DUNN AVENUE, FOR A PROJECT KNOWN AS "DISTRICT 8 TREE PLANTING PROJECT", IN COUNCIL DISTRICT 8; PROVIDING FOR THE PUBLIC WORKS DEPARTMENT TO OVERSEE PROJECT; DIRECTIVE TO UTILIZE THE COUNTYWIDE TREE PLANTING CONTRACT CP-0100-19; PROVIDING AN EFFECTIVE DATE.

Explanation of Appropriation - The funding above is being (C) Protection and Related appropriated from the Tree Expenses Trust Fund, Subfund - 15F (Ordinance Code) for a tree planting project known as "District 8 Tree Planting Project" to include site preparation, the purchase and planting of trees, and including a one (1) year guarantee and maintenance of the plant material, on City rights-ofway in District 8, as shown and described in Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Proj Info, August 19, 2019 - NCSPHS", through the City's Countywide Tree Planting Contract CP-0100-19.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funding for tree plantings, as shown in Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Proj Info, August 19, 2019 - NCSPHS", in three locations as follows:

- (1) Yancey Park, located at 3301 Soutel Drive. The City's Urban Forestry team worked with the Parks, Recreation and Community Services Department, the Public Works Department, and the coaching staff of Yancey Park to determine tree locations that would: impede parking or utilities; provide shade; and leave active recreation areas open.
- (2) A median on Pritchard Road at Old Kings Road. Forestry Team has proposed trees to conform to the surrounding and existing landscape, and so as not to create a site obstruction.
- (3) The right-of-way of Moncrief-Dinsmore Road, from Trout River Boulevard to approximately Dunn Avenue. A mixture of deciduous and evergreen trees are proposed for the purpose of creating a buffer/screen along the long stretch of road.

Section 5. Contract Services. The City is hereby authorized to procure the services of the City's Countywide Tree Planting Contract CP-0100-19 for an amount not to exceed \$263,836.95, to complete the project, as shown in Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Proj Info, August 19, 2019 - NCSPHS". The project is known as "District 8 Tree Planting Project".

Section 6. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
