Appropriation. For the 2018-2019 fiscal year, 16 within the City's budget, there are hereby appropriated the 17 indicated sum(s) from the account(s) listed in subsection (a) to 18 the accounts listed in subsection (b): 19 20 (B.T. 19-106, attached hereto as **Exhibit 1** and incorporated herein 21 by this reference): 22 (a) Appropriated from: 23 See B.T. 19-106 \$394,136.00 24 (b) Appropriated to: See B.T. 19-106 25 \$394,136.00 Explanation of appropriation: 26 (C) The funding above is a SAMHSA grant from the U.S. 27 Department of Health and Human Services. No City match is 28 required. A copy of the grant award letter is attached 29 hereto as **Exhibit 2** and incorporated herein by this 30 reference. 31

Section 2. Carryover. The funds appropriated in Section 1 of this ordinance shall not lapse but shall carryover into subsequent fiscal years. This is a five-year grant beginning May 31, 2019, through May 30, 2024. The grantor allows funds to be carried over through a waiver that can be requested by the courts in the event that funds are not expended in the budget year and are anticipated to be spent in the next budget year.

Section 3. Purpose. The purpose of the appropriation in 8 9 Section 1 is to provide additional funds to be used in the Family 10 Dependency Drug Court to expand and enhance the quality and/or intensity of services. The grant will allow the courts to implement 11 evidence-based treatment modalities, increase available bed days 12 for adult residential treatment, increase the use of medication-13 assisted treatment, and provide random, observed drug and alcohol 14 15 testing. Intense substance abuse/mental health treatment services and case management will also be provided with the various support 16 17 services. Staffing will be provided through current staff members.

18 Section 4. Effective Date. This ordinance shall become 19 effective upon signature by the Mayor or upon becoming effective 20 without the Mayor's signature.
