ORDINANCE APPROPRIATING \$543,289.35 ΑN ΙN GRANT FUNDS FROM THE U. S. DEPARTMENT JUSTICE, BUREAU OF JUSTICE ASSISTANCE, THROUGH THE STATE ATTORNEY'S OFFICE, FOURTH JUDICIAL CIRCUIT OF FLORIDA, UNDER THE FISCAL YEAR 2018 NATIONAL SEXUAL ASSAULT KIT INITIATIVE (SAKI), WITH NO LOCAL MATCH, TO PROVIDE SALARIES AND BENEFITS TO ONE FULL-TIME COLD CASE DETECTIVE IN FISCAL YEAR 2020 AND FISCAL YEAR 2021 WHO WILL WORK EXCLUSIVELY ON SAKI, INCLUDING TRAVELING TO COLLECT LAWFULLY OWNED EVIDENCE, AND TO PROVIDE FUNDS FOR THE PURCHASE OF ADDITIONAL SUPPLIES TO FACILITATE THE COLLECTION AND TESTING OF DNA EVIDENCE, AS INITIATED BY B.T. 20-007; APPROVING AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE DELIVER, FOR AND ON BEHALF OF THE CITY, THE SUBCONTRACT BETWEEN THE STATE ATTORNEY'S $4^{\,\mathrm{TH}}$ OFFICE, JUDICIAL CIRCUIT, AND JACKSONVILLE SHERIFF'S OFFICE (JSO); PROVIDING FOR OVERSIGHT BY THE JSO DEPARTMENT INVESTIGATIONS AND HOMELAND SECURITY: APPROVING POSITION, AS INITIATED BY R.C. 20-005; PROVIDING FOR AN EFFECTIVE DATE.

(c) Explanation of Appropriation.

The funding above is a grant from the U. S. Department of Justice, Bureau of Justice Assistance, through the State Attorney's Office, Fourth Judicial Circuit of Florida, under the Fiscal Year 2018 National Sexual Assault Kit Initiative (SAKI). No local match is required. The grant period is from October 1, 2018, through September 30, 2021. A copy of the sub-award letter from the State Attorney's Office is attached hereto as **Exhibit 2** and incorporated herein by this reference.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide salaries and benefits to one full-time cold case detective in Fiscal Year 2020 and Fiscal Year 2021 who will work exclusively on SAKI, including traveling to collect lawfully owned DNA evidence, and to provide funds for the purchase of additional supplies to facilitate the collection and testing of DNA evidence.

Section 3. Approval and authorization. There is hereby approved, and the Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, the Subcontract
