AN ORDINANCE AMENDING CHAPTER 656 (ZONING CODE), PART 10 (REGULATIONS RELATED AIRPORTS AND LANDS ADJACENT THERETO), SECTIONS 656.1005.1 (SUBSECTION Α. REGULATIONS APPLICABLE TO DESIGNATED CIVILIAN AIRPORT ENVIRONS), 656.1005.2 (SUBSECTION В. REGULATIONS APPLICABLE TO DESIGNATED MILITARY AIRPORT ENVIRONS), AND 656.1009 (EDUCATIONAL FACILITIES), ORDINANCE CODE, TO CONFORM TO SECTION 333.03, FLORIDA STATUTES, REGARDING LOCATION OF EDUCATIONAL FACILITIES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, by Chapter 2016-209, Laws of Florida, the legislature amended Section 333.03, Florida Statutes, to remove the prohibition of construction of an educational facility of a public or private school at either end of a runway of a publicly owned, public-use airport within an area which extends 5 miles in a direct line along the centerline of the runway, and which has a width measuring onehalf the length of the runway; and

WHEREAS, the City of Jacksonville Zoning Code should be amended to conform to Section 333.03, Florida Statutes, as amended in 2016, to provide flexiblity for locating schools; and

WHEREAS, removing such prohbition from City the Jacksonville Zoning Code does not impact the rules protecting areas surrounding airports from incompatible development, including Accident Potential Zones, Air Installation Compatible Use Zones,

Sec. 656.1009. - Educational Facilities. Reserved.

No new educational facility of a public or private school, with the exception of aviationschool facilities, shall be permitted within an area extending along the centerlineof any runway and measured from the end of the runway and extending for a distanceof five miles and having a width equal to one half the runway length. Exceptions approvingeonstruction of an educational facility within the delineated area shall only be grantedwhen the Planning Commission and/or City Council make specific findings detailinghow the public policy reasons for allowing construction outweigh health and safetyconcerns prohibiting such a location.
