SENATE RESOLUTION SUPPORTING BILL 64. DESIGNATING A PORTION OF STATE ROAD I-295/EAST BELTWAY 295 BETWEEN ALTA DRIVE AND PULASKI ROAD ΙN DUVAL COUNTY AS "OFFICER LANCE CHRISTIAN WHITAKER HIGHWAY"; DIRECTING THE CHIEF OF LEGISLATIVE SERVICES TO SEND A COPY OF THIS RESOLUTION TO THE FLORIDA DEPARTMENT TRANSPORTATION, OF DUVAL LEGISLATIVE DELEGATION, THESENATE PRESIDENT AND THE SPEAKER OF THE HOUSE; PROVIDING AN EFFECTIVE DATE.

WHEREAS, during the 2019 Legislative Session, the Florida Legislature passed Senate Bill 64, which makes honorary designations of transportation facilities through Florida and directs the Florida Department of Transportation (FDOT) to erect suitable markers for those designations; and

WHEREAS, Senate Bill 64 designates that portion of I-295/East Beltway 295 between Alta Drive and Pulaski Road as "Officer Lance Christian Whitaker Highway"; and

WHEREAS, Section 334.071, Florida Statutes, provides that a city or county must pass a resolution in support of a particular designation before road markers are erected; and

WHEREAS, the City of Jacksonville wishes to honor Officer Lance Christian Whitaker and requests that the Florida Department of Transportation erect suitable markers designating a portion of I-295/East Beltway 295 between Alta Drive and Pulaski Road in Duval
