Vernon, 10 Kentucky, attended Transylvania University and graduated from the University of Cincinnati with a degree in political science and 11 began his railroad career in 1962 in Louisville as a brakeman for 12 the Louisville & Nashville Railroad; and 13 14 WHEREAS, his career spanned a period of tremendous change in 15 the railroad industry, with scores of small railroads being purchased and consolidated into a few major national carriers, one 16

of which was CSX Transportation. Mr. Carpenter rose through the ranks of the railroad as it grew, moving to Jacksonville in 1988 and eventually becoming President and CEO of CSX Transportation, headquartered in Jacksonville, from 1992 to 1999 and ultimately Vice Chairman of CSX Corporation, the railroad's parent company, until his retirement in 2001; and

WHEREAS, Pete Carpenter was widely known and respected as a leader who could balance the best interests of the company with those of its employees, and who managed a change in the corporate culture to one of shared responsibility and participatory decisionmaking, guided along the way by his folksy sense of humor and optimism; and

WHEREAS, in addition to his corporate responsibilities, Mr.
Carpenter was prolifically active in community and civic affairs,
serving on numerous corporate boards of directors, as board chair

for the Jacksonville Symphony, and on the boards of the St. Johns 1 2 Riverkeeper, the Salvation Army, the Cummer Museum and Gardens, 3 the Community Foundation for Northeast Florida, and many others. Pete and his wife Marilyn had a particular affection for the 4 5 Jacksonville Symphony Youth Orchestra and played a significant role in the founding of the First Coast Community Music School. He also 6 7 served at the state level, having been appointed by Governor Jeb Bush to the Commission on Workers' Compensation Reform and the 8 9 Advisory Council on Base Realignment and Closure; and

10 WHEREAS, in his many roles, Pete Carpenter was known as a man 11 of integrity and compassion, dedicated to getting the best out of 12 his employees and peers, and treating everyone with respect and 13 courtesy; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

The City of Jacksonville hereby honors and 15 Section 1. life and accomplishments of Alvin 16 commemorates the "Pete" 17 Carpenter, and expresses its sincere condolences to his family, colleagues, and many friends and admirers upon the occasion of his 18 19 passing. Mr. Carpenter was a stellar corporate leader and community 20 steward, and his countless contributions will be long and 21 gratefully remembered.
