29 Section 2. Purpose. The purpose of the appropriation in 30 Section 1 is to balance revenues and expenses at the project level

as part of a clean-up of Enterprise Resource Planning (ERP). A 1 clean-up of all all-years funds is required before the ERP go live 2 date. The transfer moves only revenue between projects with the 3 following exceptions. Expense budget changes: 1) transfer \$1.29 4 between capital project subfunds to balance negative cash issues in 5 subfunds 310 (\$0.15), 31Q (\$0.10), and 31U (\$1.04); 2) place any 6 7 residual cash in a contingency for future appropriation within subfunds 31P (\$642.96), 31T (\$0.04), and 31L (\$23,171.51); 3) 8 9 reduce project DA000-01 in subfund 31R by \$0.64 to cover negative 10 cash in the fund of \$0.41 and negative expense budget of \$0.23 in project CC0001-01, and reduce project DA0001-01 in subfund 31L by 11 \$0.14 to cover negative expense budget in project CC0001-01. 12

Section 3. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
