- (7) On page 3, lines 22 and 29-30, strike "on file" and insert "Revised On File";
- (8) On **page 4, line 2½,** <u>insert</u> a new Section 6 to read as follows:
  - "Section 6. Further Authorizations. The Mayor, or his designee, and Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City,

any and all additional documents necessary to obtain the United States Department of Transportation (USDOT) grant funding via the Florida Department of Transportation (FDOT) (described in Section 1 above), including, but not limited to, federal and state agreements, contracts, and other related ancillary federal and state grant documents. Any such additional agreements executed by the Mayor shall not obligate the City beyond the grant terms agreed to in this ordinance.";

- (9) Renumber remaining Sections accordingly;
- (10) Remove **Exhibit 2** and replace with **Revised Exhibit 2** attached hereto, which attaches the Revised CIP Project Information Sheet;
- (11) Remove **On File** document and replace with **Revised On File** document attached hereto, which places the Revised Agreements On File;
- (12) On **page 1, line 1,** amend the introductory sentence to add that the bill was amended as reflected herein.
