8 111.850 (KIDS HOPE ALLIANCE TRUST FUNDS),
9 *ORDINANCE CODE*, TO CHANGE THE MAXIMUM AWARD OF
10 THE KIDS HOPE ALLIANCE MINI-GRANTS PROGRAM
11 FROM \$5,000 TO \$25,000; PROVIDING FOR
12 CODIFICATION INSTRUCTIONS; PROVIDING AN
13 EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Amending Chapter 111 (SPECIAL REVENUE AND**
17 **TRUST ACCOUNTS), Part 8 (Education, Library and Children), Section**
18 **111.850 (Kids Hope Alliance Trust Funds), *Ordinance Code*.** Chapter
19 111, (SPECIAL REVENUE AND TRUST ACCOUNTS), Part 8 (Education,
20 Library and Children), Section 111.850 (Kids Hope Alliance Trust
21 Funds), *Ordinance Code*, is hereby amended to read as follows:

22 **Chapter 111 (SPECIAL REVENUE AND TRUST ACCOUNTS)**

24 **Part 8 (Education, Library and Children)**

26 **Sec. 111.850. - Kids Hope Alliance Trust Funds.**

27 *Part A. Kids Hope Alliance Trust Fund*

28 There is created within the General Trust and Agency Fund a
29 trust fund account to be known as the *Kids Hope Alliance Trust*
30 *Fund*, hereinafter called the *Fund*. The Chief Executive Officer
31 ("CEO") of the Kids Hope Alliance ("Board") shall deposit into the

1 fund all donations and contributions of money, including gifts and
2 grants, received for use toward achieving the purposes, functions
3 and goals set forth in the Essential Services Plan for Kids and
4 Chapter 77, Ordinance Code. All such donations and contributions
5 shall be accounted for separately within the fund by the CEO. All
6 sums placed into the fund, which shall include all interest earned
7 or accrued thereon, shall be appropriated by the Council prior to
8 expenditure, and shall be utilized for operating, maintaining and
9 improving the Essential Services Plan for Kids provided in Chapter
10 77, Ordinance Code, and to provide funding for the Board's mini-
11 grant program. The mini-grants of up to \$25,000 ~~\$5,000~~ may be
12 awarded to organizations that provide programs for children and
13 youth in the Jacksonville community and that are within the
14 services, programs and activities identified in the Essential
15 Services Categories under Chapter 77, Ordinance Code. The mini-
16 grant funds shall not lapse at the close of any fiscal year, but
17 instead shall carry over to the next fiscal year. Funds provided
18 through the Fund shall not be used for ongoing program costs or
19 fundraising efforts. The CEO shall make grant and other expenditure
20 recommendations to the Board. The Board shall approve all
21 expenditure amounts and the CEO shall award the amounts as directed
22 by the Board. The CEO or its designee shall review the expenditures
23 to ensure that the funds were expended for those items as approved
24 by the Board. The Director of Finance and Administration, or his
25 designee, is authorized and directed to make disbursements from the
26 Fund after appropriation by the Council and upon written
27 requisition of the CEO, or his designee, subject to the
28 availability of funds in the Fund. Nothing in this Section shall
29 prohibit or otherwise limit any appropriations which may be made by
30 the Council to the Board for use toward achieving the purposes,
31 functions and goals set forth in the Essential Services Plan for

1 Kids and Chapter 77, Ordinance Code.

3 **Section 2. Codification Instructions.** The Codifier and
4 the Office of General Counsel are authorized to make all chapter
5 and division "tables of contents" consistent with the changes set
6 forth herein. Such editorial changes and any others necessary to
7 make the *Ordinance Code* consistent with the intent of this
8 legislation are approved and directed herein, and changes to the
9 *Ordinance Code* shall be made forthwith and when inconsistencies are
10 discovered.

11 **Section 3. Effective Date.** This ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
